## ***THE TRUTH IS A SECRET***

This Australian national strategy, developed to stop child sex abuse, commenced on the 11/11/2008. Remembrance Day.

I have three daughters, who range in age. The eldest is now 16yrs old, and I will refer to her as E this is her first initial. My middle daughter is now 7yrs old, and I will refer to her as C this is also her first initial. My youngest daughter is now 5yrs old, and I will refer to her as G as well this is her first initial. Now I have an "ECG" .One that I can now feel, not just a tracing of a hearts functioning on a monitor. The feeling is like any parent will tell you that your own children bring the most meaning to your life and that is how we feel the real meaning of what is unconditional love.

My middle child C was then only 5yrs old, and I was extremely concerned that this child would not be ready to commence school in the year 2009. My C was extremely hyperactive, with a very short attention span. But my main concern with her was her behavior. I am a registered Nurse of twenty years and my husband a Doctor of twenty-five years. All I will say is she was more than over sexual, but my husband reassured me nothing was wrong with her behavior, it was just our C. However he was concerned that if anybody else ever saw this child's behavior, they would think he had molested her, and he was worried about that. I constantly had to reassure him, that that was ridiculous, I know him, and I would make sure I would defend him. My C was just different that is all, unique and special. This became a family joke. She is just like you, my husband told me, its genetic, all that masturbation, and familiar knowledge of her father's penis, which she referred to, as "I love your big fat fanny daddy "which she would always touch as she went past him. Then there was the "acting out" on her baby sister. I did not know that this is what it was at the time. They would play a game that they called milking the cow, but it had nothing to do with milking cows. One of my youngest children usually G would get into a position, where she would be on all fours, I guess like a cow, but C would be licking G.s anus. My husband made this "game" sound hilarious."Bloody hell, C is molesting G; we are going to have to protect G from C. How could a 5yr old girl molest a 3yr old girl? The expression used when he would say this, I understand now the meaning and why it was exaggerated and over dramatic. Not at all funny, I wish I knew then, but I did not. My C was the way she was, because she is just like me! He is a Doctor, I believed everything he told me at that point in time. Obviously, things have changed a lot since then.

I stopped working, and started teaching, my C letters, colors, numbers and incorporated it all by teaching her the piano. The method developed over a few weeks but it was so effective, that I never wanted it to end. My C was playing the piano, composing her own compositions, that were musical and a joy to listen to. Many things changed over a period of about six weeks. I had my two youngest children in a routine, in bed by themselves, instead of always having to sleep in our bed. The television was eliminated, and I read books

instead, but always read something special at bedtime, that mostly would involve fairies and angels. This was because the notes for F and A on the piano were referred to as angel and fairy, this was easy for them to remember. To get them to sleep on their own, was hard at first, until I discovered, that when fairies visited them at night and left fairy dust and presents in their doll house, which I placed on their dressing table, so that they could easily see it. These children could not wait to go to sleep. I was having the most fun I have ever had, doing this with my C and G. I could see how much more they enjoyed their little lives, with all this imaginative play, that was teaching music, but more than that as well. (What it taught, is the **SECRET**) My C no longer had any sexualized behavior, she was completely changed and along with G lived in an imaginary fantasy world filled with fairies, angels and magic. But this world that I created for my two youngest children, they honestly believed was real, and not only that, but they were protected from harm. My youngest child was so scared of the dark, but she was now able to fall asleep in her own bed comforted and content.

At the same time, my relationship with my husband changed as well. Our sex life was taking over my life. My husband demanded anal sex, every night, and it would last for hours. He wanted me to engage in group sex, and his demands were constant. I knew I would not be able to keep up with him, I did not want to. He said that he was having the **best sex** of his life, I said I wanted a **divorce**. There was Viagra all over the house, hidden of course, our marriage was over!

Little did I know that at the time, I was acting just like a soldier in a war would, my actions whilst trying to teach my middle child the piano. Prevented and protected my children, from a dark secret, I knew nothing about. Not on a conscious level, but maybe on an unconscious level. I never let either of these two youngest children out of my sight, I was fearful that something tragic would occur if I did. C's behavior would at times be dangerous, and she would lead G astray e.g. climbing the pool fence, running away in shopping centers, and running in front of cars, when she could get away from me. I was always having to yell at her to stop, as I would see an accident about to happen, and try to prevent it. My own grandmother used to say she could see an accident happen before it actually happened, I now know why! She had a lot of experience with her own children and grandchildren. The catalyst for me stopping working every weekend, was that C had turned on a hairdryer, and got in the bath with G to dry Barbie dolls hair. I had been at work all day at the hospital, came home to find my husband asleep in the cubby house and the children not cared for. I put the two youngest in the bath, and sent the eldest to the shop to get food for dinner. Next I heard a strange noise, went into the bathroom, and saw what could have been the last living memory of my children alive. I made no sound, pulled the hair-dryer straight out of the wall. I will not say anymore.

I went to WAR in 2009, the Family Law Court, held in the Federal Magistrates Court of Australia. My husband took me there, for custody of our children. I had had to get a restraining order against him in the local District Court that he was disputing as well. It all happened very fast, and I honestly did not comprehend all of what was happening. But my husband did, he planned it, and orchestrated a magnificent manifesto. Originally the court gave shared custody of our children, with me having them 65 percent of the time. This I thought would work just fine. I was wrong.

The very first time my husband had my baby G alone on her own, whilst her sisters were at school, he viciously and premeditatedly sexually abused her. How do I know, the evidence was long and coming, as it was obvious when I got my lawyers billing. My husband ran two court cases at once, with different lawyers. One with a criminal lawyer, in Southport for a DVO, and the other a family law lawyer for the Family Law Court held in the Federal Magistrates Court in Brisbane. It was not until the billing arrived that I acknowledged to myself that this was strange, and not mentioned in the Federal Magistrates Court, as it is extremely significant. My baby disclosed to me, two days after I got her back from her father. which happened to be the very same day I had to go to The District Court in Southport, for his challenging my DVO against him. G on that day she was returned by him was sick and so was my eldest daughter, so when I went to Court my E looked after G at home. After a long day with my solicitor, and after picking up C from after school care, we returned home exhausted. I noticed almost immediately that G was not herself, and I thought it maybe because she had been sick .G was acting very strange, and in fact she was being really awful to me. My eldest daughter noticed it as well, and made the comment that G was so perfectly behaved at Dads house, what was wrong with her now. She could not remember what she had done when she was with her Daddy, I asked her what her day with Daddy had been like, as she was not talking, and I wanted her to. It was the first time she spent alone with her Father, I thought they would have done something really special, as this is special. She could not remember, she said, and I prompted her with different scenarios of what she might have done, still nothing. Then she remembered collecting shells at the beach, but would not elaborate on this any further. She refused to eat, bathe or go to bed. Then almost before her Father was to collect her. for his next access visit with him again, she told me the SECRET. She told me, because I made her feel safe, with the method developed for teaching C PIANO, with the use of creative imagination. I was not expecting to hear what I heard, I just knew because of her behavior, something was wrong, and I thought her father might have said something about me that had upset her. **(HE HAD BEEN TELLING MANY PEOPLE LIES ABOUT ME, ESPECIALLY MY ELDEST DAUGHTER)** I told my baby how much I love her, and did she know she was being mean to me? Yes she knew she was being awful, I assured her I did not care, as I love her even when she is being naughty. I then said if anybody tells you something bad will happen, when you have been told not to tell something. Do not believe it! Nothing bad will happen, and that the Angels and Fairies will protect you anyway. This is when she told me what her father had done to her, she did not understand what it was of cause, but she believed she would be in trouble if she told me. Because what her father had done to this small innocent child, made her defecate in the bed she was in with him, so badly, that her father had to soak the sheets in the bathtub. I did not ask her any questions about what she had already told me, I comforted my baby, and said you are not in trouble, and I will not tell Daddy what you have told me. Her father told my baby not to tell mummy because mummy is mean. My baby said, " but you're not mean mummy."

My husband had already started a hate campaign against me, and I was being told I was viewed as being vexasous by my husband of cause. I immediately contacted my solicitor, she was not there. Then I contacted DOCS, who contacted the police. My baby was interviewed by police by herself for almost two hours. I gave my statement. Then I was told to keep my two youngest children safe, and did I want to press charges?, Yes I did ! My baby's

video disclosure was played in court, and I have only seen it that one time, and it is horrific. But this case with the police, was closed within 48hrs, the children were deemed not to need protection, unsubstantiated.

This did not need to be confirmed by DOCS or POLICE, I knew it was true, I never spoke to my husband about what my baby told me, I would not give him the opportunity, to make up an excuse, he raped my baby! I broke Court Orders, went to court 29 times, then there was a 9-day trial. I ran out of money, and self represented myself. I lost custody of all my three daughters. I had to hand the two youngest over at the courthouse. I was accused of coaching, and emotionally damaging to my children. I said my husband is a pedophile, and should be put in jail! NOT VERY SMART. The Federal Magistrate Judge resigned without ever giving reasons for his judgment, and I have an appeal accepted. This commences on the 27<sup>th</sup> of August 2010.

Because this commenced on the 11/11/2008, to me this has a very deep further and even more significant impact. The very meaning of Remembrance Day and of other significant events occurring around this very theme in my own life and that of my children's. I failed last year to protect my children, who are now, all being abused in many different ways. But the two youngest, sexually, psychologically, emotionally and spiritually as well. I was made hand over my two youngest children in the court house, the last day of the trial, with the knowledge that they were wanting to come home with me, and I knew they would never be coming home with me again. The words ring in my ears still, when I had to say goodbye to my babies. My C was over her father's shoulder reaching out to me, my G clinging onto me and we all were crying. (he stood looking, with a smile on his face almost laughing) I said just REMEMBER, every time you are thinking of mummy, mummy is thinking of you, always REMEMBER, and I will get you back, never forget! Promise Mummy you will never forget. They promised, the emotion I cannot explain, it is unimaginable, is all I will say. I will never forget it and will always REMEMBER.

To win the WAR you must not let the opponent know any of your moves, YOUR STRATEGY and whoever has the best strategy wins. Being a good Chess player, try to be two steps ahead. This is now about to be tested, a field study you might say. I am using my strategy, THE TRUTH IS A SECRET. An Australian Strategy, to stop Child Sex Abuse. To win Custody back of my three children, and make sure, that the PEDOPHILE goes to JAIL.

I have had absolutely everything taken from me by this man, I was hospitalized, in a psychiatric hospital for ten weeks, put on an ITO, an INVOLUTARY TREATMENT ORDER, and told I had "paranoid schizophrenia", of course, my husband had a major hand in this. I was forced to take antipsychotic medication, which I spat out anyway. My Nurses Registration was suspended for six months, and I now have to prove I am fit to work, which I have just achieved. I do not have "Paranoid Schizophrenia", and have had that confirmed by five psychiatrists since I left hospital, but getting the head of psychiatry to confirm this, in writing, as well as his willingness to say, it in court is more than a bonus. While I was in hospital my husband took my house as well, and everything that I own in it, and that includes my clothes. I cannot get social security, it is always refused. My mail never turns up, if it does, it comes too late. So this field study if successful, must be employed, as it will have worked against all odds. I have no parents, no job, no money, but thank god, I

have and know my own mind, despite the opinions of others, who did not know the TRUTH.

You read the Strategy, the PEDOPHILE can read it in JAIL, at his leisure, I will allow him this much. He has an illness you know, and I am a nurse, the man needs help! Fortunately, jail is the best place to get that help. I have learned only in the last few days that he is a freemason, as I have little knowledge of this organization. I am not researching it, all I will mention is I never knew he was, a member of this organization. They are a secret society, and that is what a Pedophile has in common with the freemasons, the secret, hidden by a mask.



*Taught by an innocent child without her knowledge. Who could not speak until she was four years old? However, what she did not say, she expressed, and that is the method for this strategy. This child is the teacher, of the most important lesson we all must learn. Be aware of who your neighbor is and who their children are. Australian citizens have a duty of care to protect innocence, and it starts in your own street. Always remember actions speak louder than words. Adults lie to protect themselves. Small children do not have to speak, just look at their behavior and it speaks louder than any words spoken.*

***Actions of any type always speak louder than words!***

*What would you do if you discovered that your neighbor is a pedophile? Obviously, you would inform the authorities and do something about it. What if you didn't know that your neighbor is a pedophile, but were told they were? You may or may not believe that person for many varied reasons. You must ask yourself, why anybody would say something so disgusting anyway, what would be the purpose. Why would anybody lie about children being sexually abused, what do they have to gain from lying. It must be the children that are of grave concern as nobody gains anything from lying about child sexual abuse!*

*You may never discover as a neighbor, that your neighbor is a pedophile, it's a secret and secrets are only ever discovered if the secret keeper tells, or their secret is discovered by accident. What is done in secret that is never meant to be found out is virtually impossible to prove even if you know that it is true. Without physical evidence, you cannot prove child sexual abuse happens. Nobody wants to believe this obscenity, even if a person is one hundred percent sure a child is being sexually abused, and is prepared to testify in a court. Without physical evidence this cannot be proven. If you accuse another person of this and it is not proven, you more than likely will be accused of defamation, possibly charged, which may result with a criminal record*

*Imagine being a small child being sexually abused, scared and frightened, being hurt by somebody you love and not understanding what is happening to you. Imagine being that small child, being told by her father that Mummy would die if she ever told what was happening to her. This is the child's own father and the child loves her own father, she*

has been given the power to destroy a whole family with his secret. However a child will tell a trusted person about sexual abuse if they feel safe to do so. Unlike many people believe many children only feel safe when away from the abuser, and in this case of INCEST, this occurs during divorce, when they are spending less time with that parent. This small child feels safe enough to tell her Mummy even though she has been told by her Daddy Mummy will die if you tell. The child is believed by her Mummy and because she is believed and Mummy is not dead, she tells police and it is on video. She is now protected from being sexually abused again, her Mummy promised. Mummy should have known better, she is sexually abused again and she does not tell this time. But she is angry and eventually she does tell Mummy why. Then she is told that what Daddy did is wrong, this is the first time she has heard that. Finally she can validate why she did not like what happened and it hurt her and made her cry. Daddy did not care about how she felt, but now she is allowed to be angry. She still loves her Daddy and still has a relationship with him, but she believes it will not happen again and she is a much happier child.

Daddy is seeing her but he has a woman with him to make sure that does not happen again. Next Mummy and Daddy are going to court a lot. This child and her two sisters want court to be over, they know what court is about. What they, but especially the child that disclosed sexual abuse, were not prepared for was that they were taken away from their Mummy. Mummy is gone and they are now being told because Mummy is bad, takes bad medicine, and is a liar who has ruined Daddy's life and their lives as well. Everything that is wrong in some way it is all Mummies fault. But the child being sexually abused is still being sexually abused and told not to tell and Mummy will not die. Mummy can't protect her, but she can keep Mummy alive and she must, she loves her Mummy. Imagine what this child's life is now like?

In 1975, a family law act section 61DA was changed from being "whatever affect the mother effects the child". "A child has the right to a relationship with both parents and the child's parents to have the right to equal shared responsibility". Mothers are losing custody of children to abusive fathers, if the father is seen to be the parent most likely to promote a relationship with the other parent. In cases of sexual abuse, were there is no physical evidence, 75% of the time the father gets custody and the Mother will not see her children again. Family law is protecting pedophiles, and already abused children are being further harmed .65% of all child sex abuse is INCEST! Section 61DA is used to prove PAS is the motivation behind child sex abuse allegations ,many men who are abusive have been able to manipulate the legal system ,to win custody of children, just with this section. Children have been placed in the care of the abuser, and damaged further, mothers alienated and certainly damaged. Evidence proves this, and that is ironic. Every Australian mother must know this rule. If a child of hers has been sexually abused by their father, and the family law court is involved. GET EDUCATED There are many web sites and men's help groups that explain the family law court extremely well. Women should access the information provided for men wanting to help men (THE NEW AGE FATHER). There are step-by-step strategies on how to get custody of the children. The information is very informative ,and the advice given in the chat rooms is priceless.

Women must use these sites to get the same information and advice. It is only fair as no information like this is accessible for women on the internet .Obviously, when in chat rooms, you would have to pretend to be a male. Warning to any mother in the position of alleging child sex abuse INCEST . Make sure you tell the Family Court, that there could be another reason for what your sexually abused child is telling you. Tell the Family Court Social Worker, and Psychiatrist, that you never saw it happen, and you have just repeated what your child has told you,(IT NEVER HAPPENED,WHEN THERE IS NO WITNESS) True belief, is not going to help you to protect a sexually abused child. It can only further harm you, and this is the truth .Better to have a strongly held Idea ,meaning that you can still act in a protective way, but are open to other possibilities for what a sexually abused child discloses.

Mothers will be seen as not being a reasonable person, if they remain adamant that sex abuse has occurred, and this has not been substantiated by POLICE or DOCS. . Do not say what you think should happen to the pedophile father. TAKE the emotion out of what you believe to be the truth for the Family Law Court .START ACTING You must appear to be the better parent able to promote a relationship with the other parent. If a psychiatrist states that you are totally inflexible in your opinion that sexual abuse has occurred, and when mothers are being assessed, the emotional attachment to the belief is used to damage a mother's reputation. Nobody is going to feel sorry for a mother who cries about what has happened to there child. The Court doesn't care, when it has been unsubstanisiated by DOCS, and Police. Mothers, not only will you be seen incapable of promoting a relationship with the father, you will more than likely be diagnosed with some kind of" personality disorder", histrionic o borderline, or cluster C, etc, this will not work in your favor at all. Then emotional attachment to your belief will be viewed as the development of some form of psychosis. This is definitely not going to work in your favor. Pedophile fathers know this well and flaws that the mother of a sexually abused child has, will be magnified and used against the mother, to assist in character assassinations. Almost all wives of pedophiles, are battered women, that are already involved in some form of therapy, and on medication of some form, or another, usually antidepressants SSRI, and or sedatives e.g.; Valium. Many women have had addictions. This characteristic of pedophile wives will be used, as a tool by the pedophile husband as a method to deflect from what they are. Mothers will be viewed as not being able to cope with parental responsibilities, for being on any form of medication. Pedophile husbands, know the Family Law Court rules, so they promote ,promote promote, their Criminal barristers advise them to. Nothing is moral or ethical in a war.

Pedophiles use Criminal Barristers instead of family law Barristers, as another tactic to win custody, by deflecting attention away from themselves again,. This is, simply because Criminal Barristers are disgusting and mean! They use a different style when cross examining a witness , to Family law court Barristers, who when compared are polite Criminal Barristers, are there to confuse the witness, not to help them. I call this the confusion technique, dates and times are swapped and jumped all over the place, and when anybody gets a date wrong, they are called a LIAR. The Briginshaw test of proof, add up how

many times a witness got it correct, and not correct and the score will decide who is guilty and who gets custody. (it is as simple as that! Not Really).. Be dishonest like the pedophile, for the safety of your children and for yourself. Be seen to be the best parent to promote a relationship for the other parent with the children. Make sure the court believes that you still have warm feelings for the other parent, you want to encourage anything that involves them in the lives of their children. I would encourage a mother to fake still being in love with the pedophile husband, hoping that they can one day be back together. If you do not show kind feelings towards your husband, you will be seen not capable of encouraging the other parents' relationship with the children NEVER SAY GUILTY, HE MUST GO TO JAIL.

When child sex abuse has not been proven in the family law Court, you must "APPEAR" to agree that it has not as well. This means your children must spend time alone with the abusive parent, without you mentioning, your prior concern that something inappropriate will take place. (this would have been deemed unsubstantiated by DOCS). The truth is that the family court is not capable of substantiating sexual abuse allegations and rely on what DOCS and Police determine which means that the outcome of Family Court investigations of alleged sexual abuse are unsubstantiated anyway. The message PROMOTE, THE RELATIONSHIP of the other parent with the children. You have to give examples of how you will achieve this and how that relationship is so positive that it needs to be really encouraged by you the Mother. Brush up on your acting skills, start lying, to save your children. You can justify this in your own mind, remember your pedophile husband is lying, you can too. The most important message is to always stay child focused, and child age appropriate. Remember this is about the children, not the best or worst parent. A book well worth reading and quoting is "CHILDREN ARE FROM HEAVEN", by JOHN GRAY Ph.D. Win custody first, and then do whatever it takes. There are many ways to get physical evidence once you know the truth. This will be explained when you get to that step, But always remember, if you get full custody of your children, the minute you walk out of the Family Law Court, you make your own rules.

### THE TRUTH, IS A SECRET.

Now with the above knowledge, if a mother is not in a child's life, do not automatically assume that she must have been a bad mother and that the children are better off without her. No child should be without either parent in their life, even pedophiles have a relationship with their children. 99 percentage of the time sexual abuse is by a male and a trusted one at that. If the Mother believes the child, and is prepared to go into a legal battle because of it, and loses due to lack of physical evidence, she has acted in the best way she knew at the time to protect her children. That is not a definition of a bad Mother. So do not assume if you have been told that a child's mother is not around because she was not only a bad mother, but she accused her husband of being a pedophile as well. When the father says he definitely is not, that this was a false and vexatious tactic used

by the mother to win custody. Don't automatically believe that you are being told the truth. First look at who is giving you the information, and know that with, no physical evidence, no child sex abuse case can be proven. Even with a video disclosure of this child when she was only 4 yrs old, made by the police that would break the heart of any human being who saw it. The father said he had no idea about why this child would say such things !.He does not know what she is talking about ? he has only ever wiped this child's bottom, after she has been to the toilet, like everybody else has? But if this is his reasoning why? why did she say it was just her father? Interesting that in 98% of child sexual abuse cases, when a child has been physically examined, there is no physical evidence anyway. No mother would lie; statistics show that in only 2% of family law cases has a mother falsely alleged child sex abuse. Many men will quote that it is very common for women to employ such a disgusting tactic to win custody of children. This is not true, and the evidence proves it.

Something that is well known to all medical doctors, especially doctors who work in the area of accident and emergency, who deal with all medical emergencies that includes not only children but adults as well. Because small children are not able to really articulate what is wrong with them, or are too small to even be able to speak at all. When there are no obvious signs or symptoms ,of an illness. Doctors will rely on the words and impressions of the mother. Doctors are taught in medical school, that if a mother is extremely concerned and worried about a Childs health, be it physical, emotional or psychological, **DO NOT IGNORE HER CONCERNS**, even with lack of clinical proof that the child is even unwell. This includes blood test results being normal. General observations like a Childs pulse, blood pressure, respirations and temperature being normal. .CT scans MRI scans and XRAYs being normal too. If a mother has been given the knowledge that every clinical test was normal, and this mother is still insisting that her child is not well, for whatever reason, even if she states it is just because her child has never been like this before! She has a gut feeling something just is not right! **NEVER EVER IGNORE, OR DEVALUE HER PERCEPTIONS!** Some people will call this a mother's intuition or the sixth sense. There is a connection that exists between mothers and their children, especially small children, that cannot be defined by our human laws, but that does not mean that it does not exist, it most certainly does. 99% of the times in circumstances where a doctor could find nothing wrong with the child, but the mother remained un convinced., this **MOTHER WAS CORRECT!** And eventually whatever was wrong with the child manifests. Because of this very phenomenon., Doctors are held liable medically when the mother has proved to be correct, despite lack of clinical medical evidence that resulted in death or irreversible physical or emotional damage. The Family Court of Law should use this already acquired knowledge, proved and tested, by science in the medical field when dealing with child sex abuse, that the mother alleges has happened and will continue to happen. " True Belief of the Mother". is genuine, and real, it is so because it is true. The Family Law act 61DA, should never have been allowed to be changed in 1975 . **WHATEVER AFFECTS THE MOTHER AFFECTS THE CHILD.** This is absolutely true, and this rule should apply up until the age of twelve years.

*A man accused of being a pedophile that actually is a pedophile, is easier to spot because he is hiding his life even more diligently. Pedophiles do not want to be found out, they obviously do not want to go to jail knowing what to expect when they get there. Everyone hates pedophiles, and jail mates hate them more than they hate anybody else, pedophiles are punished in jail. A blind eye is turned, by security and police to this treatment of a pedophile when in jail. Pedophiles are narcissistic, they have no ability to feel any empathy for their victims what so ever, and they do not believe they are really doing anything that wrong. If they feel threatened by anybody, they will do whatever it takes to remove that person from their life.. If the Mother of their own children is a threat, because she knows the truth, he will assassinate her character, blatantly lie, and enlist important people to help him achieve this. A hate smear campaign will be the end result. People diagnosed with a narcissistic personality disorder, account for only three percent of the population. This however would be much higher in reality. Remember there is nothing ever wrong with a narcissist ! Of this three percent, seventy five percent are male. .Narcissists care only about themselves, they are incapable of anything else. Ironically they are very insecure , have feelings of inadequacy and low self esteem. When the Mother of these innocent children is out of the picture, the pedophile is out of control and will not stop sexually abusing unless he is caught! You may be wondering how he escape from being caught, well he does not let people into the life he has with his children for starters. He will make sure not to get caught in the act, so if he has the “means” his house will have High Tech Heavy Security Surveillance. Obviously he will not want to involve the police unnecessarily..He will tell everybody he needs this type of security for many reasons, other than to hide his disgusting putrid filthy dirty obscene unforgivable secret. He will fear for his life, not because his life has been threatened, but because he has been found out, and knows how society thinks. But he is more than very aware of what the mother of his children thinks about pedophiles, he can even remember a day when they both heard on the radio whilst driving, news of a little three year old boy who had been sodomized by his own father. He could not reveal that he was envious of this other father pedophile, but he did have to pull the car over to the side of the road , because his wife was vomiting after hearing the news. Of cause he pretended to be as disgusted as she was, but he just could not find the tears himself that his wife displayed. He can imagine that as she now knows he himself is doing this to their youngest daughter, and how fiercely protective she is of her children, she could quiet possibly be more than just vomiting.. But he cannot pretend to know how she feels, he honestly has no idea and does not care anyway. This now absent mother will be described as mentally unstable, drug addicted or schizophrenic, capable of murder, but only of murdering him. (Didn't he say she made it up?).*

*He needs High Tech Heavy Surveillance, and will also enlist the help of neighbors to be on guard if they see anything, to call him immediately, he will use the safety of the children as the reason for all these measures. He cannot tell them the truth”, he is too smart for that”. unless one of the neighbors is a pedophile as well. Then they will work as a team .Pedophiles share there experience with other pedophiles .They are all members of a ring, and communicate with other members, using pedophile codes. Pedophiles always keep their own treasures, collections of child pornography and their own pedophile activity memorabilia. This includes their own child victim's pornographic videos, and pictures,*

as well as clothed and unclothed pictures of their own child/children victims. Beloved treasures that a child valued, it may be a necklace, bracelet ,or even a certain special stone or shell, but the child has really cherished it. These are under lock and key. Pedophiles groom the child victim, this is very seductive for pedophile, the child has been chosen, it is never a random choice. One of the techniques employed is to photograph the child a lot, and to gradually persuade the child to perform sexual poses and acts. They can look back and look at what they achieved, and this arouses them. Also internet activity must never be seen, especially by police, and there are many ways to hide this. Pedophiles write in code to other pedophiles but the general public is not aware of this. Pedophiles have wised up to internet tracking done by ARGOS, and a select group transmit their activity to other pedophiles with CCTV using radio waves which goes undetected.. This is also achieved using radio waves, for mobile phone internet data Then there are pedophile rings that are international, and activity is broadcast over international satellite TV ,transmitted using radio waves. Special transmitting and receiving devices that are used to transmit data over satellite are visibly seen on outdoor antennas of the houses where this activity is being carried out. Also at night special satellites used for this activity can be seen in the sky, which are easily distinguishable from stars. If a person with specialized knowledge of pedophilia, enter the house of a pedophile, and start looking it will be found. The pedophile home, is a secret as well, and it is never to be discovered. High Tech Heavy Security Surveillance is employed. Anything used to keep people from entering the pedophile home, is done to protect their treasures and themselves, it is never about the safety of their own children. **THEY DO NOT WANT TO BE CAUGHT.**

When you realize that you're dealing with, a Narcissist it is simple everything is about them! They are **INCAPABLE OF CARING** about anybody else, which includes their own children, parents and their own other siblings They have no remorse what so ever about hurting a defenseless child or harming another human being if it suits their purpose. They believe that they are superior to everybody, and they are never wrong, it is always somebody else's fault. The word **SORRY** does not exist in their vocabulary, they have never felt that emotion, so with honesty they are not sorry. They have to fake these emotions ,pretend ,they have to act, which is extremely difficult, as to be able to act ,one needs to know what certain emotions feel like, and to show empathy you have to have experienced it. With this lack of experience and insight, it makes it easier to spot the narcissist, as one of his characteristics is over dramatization. Yes it is fake, and you can only fake it for so long before somebody notices. (Pedophiles do not know this feature, about themselves) .But once you are educated about the behaviors of pedophiles, this feature of over dramatization of emotion is obvious.. This is a very important feature, and without the knowledge of this feature, one would never understand the reason for this, without knowing the pathology behind it? You may already know a person who does this, thought that they were a little strange, even creepy. This information may in this case be very enlightening for you!

An important part of this strategy is to know the profile of a pedophile, this is the part of the knowledge you need, to be able to distinguish who a pedophile may be. Without this knowledge a pedophile will not be found out. Pedophiles come in all shapes and sizes, they can be well educated or not so well educated, good-looking to ugly looking, they can be anybody really. But they all have characteristics that are the same. They are not only attracted to children, they have the mentality of children, and relate well with children because of this. If they do not have their own children, they will often be in employment were they are able to easily access children.99 percentage of pedophiles are male.50 percentage ARE MARRIED. They engage in activities that entice children, these being, theme and amusement parks activities, and anywhere children like to be, so that they can access children, and also to gain a child trust, this is part of grooming process ,of the targeted child victim. In many ways, this compares to what young males do when they want the attention of a selected female, and how they go about trying to win her affections, with gifts and various things. The method used by both is enticement, whatever it takes to achieve this goal, This is what is referred to as the beginning of courting (the subject of desire is given so much attention, she does feel affection for the male suitor, as she is made feel unique and special) This is healthy and to be encouraged in young adults. Pedophiles are grooming an innocent child , engaging in any activity that children enjoy, to entice the child for the pedophiles sadistic sexual perversions, it is completely dysfunctional unhealthy and dangerous, The child is then brutalized, and used sexually, for the pedophiles own pleasure. The child is just an object of sexual pleasure, a Childs, feelings, pain and suffering have absolutely no effect what so ever on the pedophile. . This feature is employed by all pedophiles, but once you are made aware of this, you will begin to see the pattern and behavior of pedophiles you already know. Don't let them know you suspect!

Most of the times features employed when grooming a child victim are applauded, taking children to theme parks ,and engaging in the actual play of children ,are viewed as an attribute that is very attractive. As a parent you are happy to think your child is having fun, when they are taken out by a trusted well known adult, many times it is the child's own father .65% of child sexual abuse is INCEST. This trusted person, usually a relative or close friend, becomes like one of the family. Their availability is also very appealing; he is always available to babysit day or night at short notice. He will refuse to be paid, instead he will bring presents for the child/children, and something for the parent as well. How could you think anything bad about a man who loves children so much, that he engages like a child himself in there play ,takes them to theme parks and other child activity places, is always available to babysit, free of charge .This could also be the Childs own father. But , after you have read all of this information about this kind, generous and often religious man, you have to admit, he does appear TO GOOD TO BE TRUE!, so then ask yourself the question WHY?..

**ANYTHING TO GOOD TO BE TRUE, IS A LIE , HE IS WEARING A MASK!**

Pedophiles always keep memorabilia of their victims, which include photos and videos. This is why they are keen photographers, and they groom a child by taking many photos of them. When it comes to naked pedophile photos, the child has already been used to

being photographed and will be easily coerced, to be photographed anyway a pedophile chooses. They do this to please the pedophile and make them happy. When you see pedophiles photo collections, unexpectedly you are made aware that, as many naked photos there are of a child victim, there are more clothed photos of this child victim. However, upon inspection the expression of the child's face is the same in both clothed and unclothed posed photos. The child is happy, not frightened, as many adults would expect. The unclothed unexpected photo of the small child victim is different, and this is insightful, as it most commonly shows FEAR AND TERROR the real , reality of what this pedophile is doing to an innocent child. A VERY TREASURED PEDOPHILE MEMORABILIA ITEM.

. A pedophile does not force himself on the child victim, he grooms and wins their trust first, this is essential otherwise, he will be caught. This man will use his charm very well; he appears happy and laughs a lot around potential and current child victims (remember this will be exaggerated). This is because he knows children will like him this way, however he is anything but happy. He is a very insecure man, but a narcissistic one and he does not care about the child at all, or anybody else. He has few relationships with adults, but he may be married. Either way, he is highly dysfunctional, and extremely demanding. If anybody questions his behavior and attitudes or disagrees with him, he loses control and eliminates whoever it is from his life. As soon as you stop making him feel good about himself, he will not like you anymore. This is something a child victim is very aware of and the child will do everything to please their abuser, but this is done out of fear and this needs to be known. A pedophile uses fear with his child victims to silence them, and it is more than affective. When the pedophile is around the child, the child will not show fear; they will be punished for this? A child is silenced with the threat of something horrific happening to somebody they love or a pet they love. If you tell, Mummy will die, your sister will die or someone beloved by the child will have something awful happen to them. Their pet will die and sometimes they are killed to show how serious the pedophile really is. This is how a Stockholm syndrome is established.

A child being sexually abused, by their own father, especially if the mother is out of the picture, cannot escape, is terrified, having their own physical and psychological survival threatened. The child without their mother, or not believed by their mother, is psychologically orphaned this child needs nurturance and protection. Being isolated from others, the child must turn to the abuser for this. Any small kindness creates hope, and the rage felt by the child is ignored and the child bonds to the positive side of the abuser. With the hope that the abuser will keep not only the child alive, but also anybody that they love as well, the child works to keep the abuser happy. The child's own needs, feelings and perspectives fade, and unconsciously takes on the worldview of the abuser. The abuser is seen as the "good guy" Police will be seen as the "bad guys", as this is how the abuser sees them. SEXUALLY ABUSED CHILDREN FEAR POLICE! The child of INCEST, is incapable of seeing their primary care giver as bad, if this child has had their mother removed from their life, the child is so psychologically damaged and traumatized by this alone. The only way the child can now survive their own reality, is to believe that they themselves are BAD. This child will view the sexual abuse as being because they are BAD.

*The Pedophile father is providing for this child, food and shelter, and the child has already taken on the pedophile's view of himself as the GOOD GUY. A child can only view the primary care giver as good. This abused, victimized, traumatized, isolated very damaged child believes their reality is for only one reason. THAT HE/ SHE IS BAD AND DESERVES WHATEVER ABUSE THEY GET.*

*The child a pedophile targets, will be showered with more than enough attention and presents, the child feels special and privileged. But this is when the abuse begins. Most of the time a child will not know what is actually happening to them, and the younger they are the more likely that they do not understand. Children under the age of three have not formed the language skills to even tell what is happening to them, and they do not know that it is so wrong anyway. If a child does tell, they most likely are not believed and the abuse continues anyway. However, young children do not have to tell, their behaviors speak louder than words, when words are never meant to be spoken anyway. Sexually abused children have one thing in common; they will act out, and have knowledge about sex beyond their years. But in development, they are chronologically younger than their biological years, and this is a direct result of sexual abuse. If you notice a child well past the age of toileting wearing nappies, even just to go to bed, 90% of the time they have or are being sexually abused. Any toilet activities that are odd are another definite sign, of being sexually abused. A sexually abused child will often develop anal fixations, and smear feces. If the child defecates often and examines their own feces, spending long periods of time on the toilet doing this THEY ARE BEING SEXUALLY ABUSED. Unlike Freud would have us believe, that this is all part of the anal stage in children's development. Small children which include girls are sodomized by pedophiles, and this is done by digital penetration. (This article is concentrating on small, and young school children) Not only is this the pedophile's preference, but it will go undetected. 98% of the times, when a child has been examined by a doctor for sexual abuse there will be no physical evidence. This is not only because they do not disclose until at least four days after, if they do disclose which is rare. When a child is anally penetrated, the symptoms can be associated with many other things, like worms, constipation and diarrhea as well. It is very difficult to get the physical evidence.*

*A small child who is being sexually abused, actually a toddler will most often refuse to talk, and will have delayed speech. If a child is not talking at the age of three, and has other behaviors that are associated with sexual abuse, such as being over affectionate, fondling their own genitals excessively, as well they may play with their anus, and or acting out (doing what has been done to them, to another child, even trying to do it to other adults), they are being sexually abused. Even if you are told something different by the parents, remember it is a child's behaviors that are the sign. Young children that are being sexually abused by their own fathers without the Mother knowing will often become hysterical when a Mother is leaving them in the care of the Father for any extended period of time. Mothers PLEASE do not ignore this, if this child is being sexually abused, this is the only way they can tell you something is wrong, Next time a child becomes hysterical, when you are only going for ten minutes, if it has become a constant pattern, and*

they display some of the other behaviors associated with sex abuse, don't leave them, take them with you. All mothers who find out that their child was being sexually abused will tell you there were many signs that they did not notice or put down to something else. But the sign that haunts is the crying hysterical child that was left alone with the pedophile, that child was crying out for help in the only way they knew how, and to the only most important person in their little lives, their MUMMY! That child will tell the Mother what was happening and say it hurt and they were crying, but where were you Mummy? Just as the pedophile father coaches and grooms the child victim. **The wife of the pedophile husband and mother of child victim is also coached and groomed to protect the pedophile and not recognize that their own child is being sexually abused.**

All pedophiles are experts on pedophilia, and can fool many people with their knowledge about pedophiles and their statements of disgust at pedophiles. There is often a grain of truth in what they say, but they are not disgusted by pedophiles, they are pedophiles. Pedophiles do not see anything wrong with what they are doing; they will justify their acts if they are ever caught. A pedophile will blame the child for seducing them or say what they were doing was actually something different, like helping the child go to the toilet, "I only wiped their bottom", "You wipe their bottom as well, and so does so and so" "they got their clothes dirty" "She is genetically just different, but if anybody saw this child they would think I had sexually abused her" "I was trying to teach her something for school" Pedophiles are narcissistic and only care about their own gratification having no guilt about what they do to innocent children's lives. When a child is in pain and crying the pedophile feels nothing at all. A child is helpless to resist and is at the mercy of the pedophile. If this is the child's own father, children will often fake being asleep so that they will not be abused. If a child under the age of four has night terrors, criminologists know this is, only because the child is being sexually abused. In fact all children that are being sexually abused have nightmares that continue even after the abuse has stopped. A child that has post-traumatic stress disorder has been sexually abused. An example of PTSD is when a child is easily startled, even by shadows, noises and some general daily activities of life. Excessive hand washing is another sign.

Children that are sexually abused will, often "split", meaning they will take on the persona of another child or imaginary friend. They do this to escape the abuse and feelings of abuse. Sometimes the child will pick a well-known TV character and want to be that character, for example Dora the explorer. The reason is they believe that they are actually bad and blame themselves for being sexually abused. Therefore, if they change characters, for example, Dora the explorer, well Dora is good and everybody likes Dora. I will become Dora and that will mean I am good, because little G is bad and little G does not like themselves. A child that is being sexually abused will very often have imaginary friends as well. A child escapes their reality this way, and if they tell their imaginary friends, no one will find out. Children that become obsessed with saints or one saint in particular that they relate to, this is another characteristic of sexual abuse, they are disgusted with themselves and believe that if they can become saint like, then they will

*be loved and cherished and so they become devoted to a particular saint.. Child sexual abuse often causes a child to disassociate during the abuse to protect which is happens to protect a child for the child's own survival.. Severe trauma in childhood can cause the development of multiple personalities, and this is discussed later under the title Ritual Satanic Abuse.*

*The signs of behaviors of sexually abused children are many, when a child is displaying many of the behaviors characteristic of sexual abuse, they do not have to tell. But this is what adults need to take notice of. Behavior of small children is the only indicator to detect sexual abuse; they are not going to tell, are they? Even when children are at school and they are being sexually abused at home, and a teacher suspects. This is not enough to do anything about the abuse. Children that are even blatantly asked about sexual abuse do not tell why would they. They know what will happen if they do! They do not want to be responsible for anything bad happening. If it means the death of a loved one, they are not willing to tell. If there is a child at school who told there Mummy about sexual abuse, after being told there Mummy would die if they did, and then Mummy was sent away after a custody battle due no physical evidence, and the corrupt Family Law Court. This child will never tell anybody ever again, this child will do everything to be good, and her Daddy has told her to. If this child is very good at school and never says anything again about what is happening to her, then Mummy will not die and maybe this child will see Mummy again one day. This child is hoping, waiting and dreaming of the day for her pain to be over and protected by the only Mother she has ever known and trusted with the secret. When she was videoed by the police, when she was only four, and disclosed the most horrific sexual abuse, it would make anyone cry. The police officer asked how many times did Daddy do that to you, was it once, or twice, "FORTY" times this little girl said. Did it hurt? This is the first time she has been asked this" yes it did and I cried". What did Daddy do when you cried..."she says nothing". At the end of the video, the police officer asks her a very important question, who do you go to when something bad happens, who do you tell? "I only tell my Mummy, I only tell my Mummy". This is said in a tiny little child's voice, which is becoming confused by now. She is confused and so are the professionals as well. The explanation is simple, as adults we will often put adult expectations on what we think a sexually abused child should display. One of these attributes is fear, but this is the expectation of the adult who has knowledge about what physically happens to sexually abused children, and as adults, we can only imagine that it is horrific. But this young child, does not know what is happening to them is so bad, and is likely part of the child's normal activities of everyday living. When a child is not displaying fear during the police interview, and becomes easily distracted, focusing on surroundings and toys in the interviewing room, they are judged as being coached, because of adult expectations. When you then know that small children have short attention spans as well, and tactics always used to keep children at ease is distraction, it makes perfect sense, the child is behaving exactly as a sexually abused child would behave. Had the child been coached, there would have been a fear factor displayed obviously, as this is an adult expectation. Some children will use adult gestures and sexual gestures, and this can be seen as coaching as well, this should be seen as another definite sign of sex abuse, as this is what is actually happening to the child. Again judged with the adult expectation that small children do not know such things, and they should not when not being sexually abused*

. With adult expectations determining if child sex abuse has occurred, and no physical evidence, it was decided by the court that the child was not sexually abused. The mother coached her own child, her sisters both new about this, and the mother allowed this little girl to talk to her other sister who was only a year older herself about what had happened. This mother also never asked the child questions about what had happened, as she was advised by a psychiatrist, this was sometimes more damaging than the sexual abuse. The mother allowed the child to be angry, and vent this anger, which is part of a healing process. The mother apparently acted in a way that no reasonable person would act if they believed the allegation. The mother is of no value, she is emotionally abusing this child, coaching her, a vindictive women trying to ruin the relationship between the father and his children. She has no true belief; she is creating a false belief in the child. Look at PAS, custody is awarded to the Father, he says he can forgive her and still loves her, and all this was out of character for her, she has been the best mother to his children and could not have wished for a better wife and mother. (PROMOTES THE MOTHERS RELATIONSHIP WITH THE CHILDREN) Now this child waits in the silence, just to see her Mummy, and that is all she waits for. She is being sexually abused, and is very aware it is all her fault .DONT TELL MUMMY, she will die, instead she was sent away. Daddy loves you more anyway, and Mummy was a bad mummy anyway, remember when(He will continually denigrate the mother, to cause complete alienation)This tiny innocent beautiful child has only seen her Mummy 4 times, under the supervision of her sexually abusing father for an hour, in almost 18 months. The Mother was to have supervised time, three times a week, and the generous and financially able to father was to pay for it. This just did not happen, he now has not got the money to provide time for the children to have any sort of a relationship, not even a telephone call, and letters sent are sent back. The children know nothing of this of course, and he has a DVO against the Mother,(Your Mother does not love you, she has a boyfriend and is going to have another baby, she has forgotten you) This brave sexually abused little girl now tells her Mummy **"I SEE YOU IN MY DREAMS MUMMY, I WILL MEET YOU IN MY DREAMS MUMMY, YOU DREAM MUMMY AND I WILL BE WITH YOU IN YOUR DREAMS "**

A pedophile is a chameleon, and master of manipulation, the more intelligent pedophile the better at the mask they portray. But just because of the better mask, does not change what they are. All pedophiles are the same; they sexually abuse innocent children without caring about the pain and suffering inflicted on the child. If anybody tries to expose them, or ridicules any of their behaviors, they are eliminated. Pedophiles are Guinness at this, as they have had to employ this technique their entire adult lives, to protect their real identity. They carry out, a well-orchestrated character assassination of the individual who poses as a threat. Mothers will be eliminated, teachers that they find any flaw with, will be discredited, their characters damaged. Every action employed by pedophiles is to protect their secret; every tactic used is to protect themselves, people are played off against one another, and this is all well planned. The pedophile enjoys watching his play, he is a sociopath and this is not really understood until you have been an actor in a play orchestrated by him. The Play has finished, and you find out how you were played and everybody else, with lies, half-truths, threats, manipulation and emo-

tional blackmail. Charm is used on everyone, appearing stupid, to gain approval works, some will even think a pedophile is naive and needs their help. Then there is intellectualization, a tactic used to impress and get people to agree with the pedophile opinions. Intellectualization is used by the pedophile when they have no idea about the subject they are professing to know about, or they want you to believe the opposite is true of them. They use studies and research, to back up what they want you to believe, which is to their benefit. Reflection and deflection are methods employed to distract any attention away from themselves even at the expense of an innocent child, or protective mother, relative or friend.

. Character assassination will be used without you being aware. When a pedophile is telling you about how bad a person is, they are actually bringing you in to help assassinate that person's character as well the only reason for this, is that you will also be perceived as part of the strategy to eliminate whoever it is from the pedophile's life, the person is capable of exposing the pedophile. When a person's character has been destroyed, they become almost like a child victim and will not be believed. Unlike the child sex abuse victim, actually any child, the damaged person becomes despised, by just about everybody. They will lose friends and family members stop contact, work associates ignore them and the list goes on. A hate campaign is very effective. Very effective though, morally wrong, but who cares? THIS IS WAR! And a very effective tactic used to win the war, nothing is fair or moral, the objective is to win at all costs .INNOCENT LIVES!

### **BEHAVIOURS OF SMALL AND SCHOOL AGE CHILDREN THAT ARE BEING SEXUALLY ABUSED**

1. Over sexual

2. Acting out. Children that interact with other children in a sexual way, even to the point of sexually abusing another child, should never be ignored. Child is not born a sexual human being, do not believe this. Children are born, innocent and free from the effects of our society, they are non-sexual, and it is this very quality that the pedophile is sexually attracted to. The child victim is not capable of being sexually attracted to the pedophile; they do not have the characteristics, hormones or natural desire. When a child is being sexual with another child, and sometimes it is aggressive. The child who is dis-

*playing this behavior is doing so for only one reason, they are being SEXUALLY ABUSED themselves by an older male relative or close family friend.*

*3. Sexual knowledge beyond their years.*

*4. Overly affectionate children.*

*5. Chronologically younger than biological years.*

*6. Wearing nappies long after toilet training is over, even if it is only at night.*

*7. Frequent bowel movements, and fascination with bowel movements, face smearing. Never believe this is because a child is uncoordinated. They are sexually abused the pedophile knows this.*

*8. Not talking at age three*

*9. Young children that cry when protective parent, relative or friend leaves them with the pedophile*

*10. The child has imaginary friends, or wants to be a certain TV or well-known character and will impersonate that character. The child has an a devotion to a certain saint, with qualities of purity and godliness*

*11. Post-traumatic stress disorder, symptoms. Child is very easily startled, by noise and even shadows or obsessive with hand washing, does not want to get dirty*

*12. When a child refuses to, or is excessively afraid to bath or undress.*

*13. When a child shows loss of pleasure in activities previously enjoyed.*

*14. When a child shows fear of certain people, and or places. General clinginess*

*15. Children at school. Who are going home and know they are going to be sexually abused, will not want to go home. They will want to go to after school care.*

*16. Children that are sexually abused, are 90% of the time in homes were domestic violence occurs. If their fathers are the abusers, their Mothers will be battered women. They have an isolated, home life, that way the abuse remains a secret*

*17. Look at the drawings of children. Children sexually abused will draw what has happened as well as what they wish their little lives were like.*

*18. Small children that have been labeled as pathological liar's .They are being labeled by the pedophile for only one reason, in case the child tells the secret. When a child's own father says this to you, they want your help assisting to label their child a liar, not because the child lies.*

*19. Children who are sexually abused have another trait common to all of them. They fear the police, and think that the police are bad. They fear the word jail, as this is what they are taught by the pedophile. You will also now know why Doctors are also to be feared and anyone working in the medical field that might detect abuse, especially psychiatrists and psychologists. The child victim will be coached on what to say and how to behave if they*

have to see these professionals. Interestingly if the pedophile is with the child, this child shows no fear of the pedophile and is seen to be relaxed in their company. This takes a very dedicated and knowledgeable professional to detect. The majority of the time it goes undetected

*20. Look at the behavior of your child as a parent, not what they say in fact what they do not say is an indicator as well. Take notice when your child is acting out of character, if your child behaves out of character after being with a person that you trust. All sexual abuse of children is done by a relative or trusted friend of the parents. Whoever the pedophile is, it is somebody you trust and least suspect. Children are never prepared to be sexually abused; they will be in shock after the event, hurt, confused and not know what to do. After the abuse and away from the pedophile, a child will withdraw into themselves. They will be angry with their parents or the mother if it is the father who is the pedophile. If a child does not remember or want to talk about what they have done when in the Pedophiles Company and care, take notice, refusal to eat after being in this person's company, sometimes even eating in excess as well, becoming obstinate and defiant after the event. "The sexually abused child is filled with rage and guilt". This is the child who wants the attention of their mummy, and to be comforted, the child is in pain. When children are hurt they want their Mummies, who they believe can fix anything, they need to be comforted, loved and protected. Mummies jobs is to look after them, however when they have been sexually abused, it does hurt, and is done by a person they love and trust. They are told not to tell their mothers, who love and protect them, because something bad will happen to them, they are very confused. A technique used by pedophiles is to make the child feel ashamed and dirty and believe what happened is their fault. If they tell their Mother, they will get into trouble for what happened. The pedophile does not just sexually abuse the child, they psychologically brainwash the child as well. Sexual abuse is the most severe form of child abuse, as it involves all other types of abuse as well. Physical abuse, psychological abuse, spiritual abuse and emotional abuse as well. The consequence of being sexually abused as a child leaves a scar that does not heal, the size may become smaller if healing occurs, and this only occurs if the abuse is found out and the healing process is allowed to take place. The adult lives of sexually abused children will be more than difficult, this is the long term devastating effect, but unfortunately this strategy does not have the time restraints to explore.*

## **METHOD**

## **PART ONE: KNOWLEDGE**

**HOW TO SPOT A PEDOPHILE? BY THEIR BEHAVIOUR! THE SAME WAY THEIR ABUSE CHANGES THE BEHAVIOUR OF OUR INNOCENT CHILDREN!** *Note; Observation of both behaviors, with the knowledge of what to look for, is the essential part of the method for this strategy to detect children who are being sexually abused.*

*"What a child expresses an adult suppresses"*

*John Gray Ph.D. Author of CHILDREN ARE FROM HEAVEN. Author of MEN ARE FROM MARS women are from venus.*

*Children at school need to be observed for behavior that one normally does not associate with abuse, but most definitely does. If you realize that children who are being sexually abused come from domestic violence in their home life, this can mean that parents are*

*married but home is fraught with conflict. Also, single parent homes as well, when they are divorced and the child is still subjected to conflict in different households, they may have been protected by one parent who is now absent while they are in the care of the abusive parent. Either way when parents are out of control, and sexual abuse is what we are talking about now, a child brings themselves into control, with a child being left on their own when parents are out of control. The child goes into survival mode. Without a parent, a child becomes their own parent, and grows up too fast. A child suppresses aspects of who they are and aspects of their development. Parents or parent out of control, a child quickly goes into control. Instead of learning to manage negative emotions and demanding desires, they cope by suppressing them. Look at the child who is well behaved, more than the one that is behaving like a normal child. Children who are people pleasers are behaving this way because in survival mode they are controlling their environment by controlling their own behavior, it is a defense mechanism.*

## **PROFILE OF A PEDOPHILE**

### **HE HAS THE OEDIPUS COMPLEX!**

*Many people believe there is a difference between pedophiles and child sexual abusers, but after much research, the following is closest to the truth. The difference is, child sexual abusers all sexually abuse children. Not all pedophiles sexually abuse children, they are sexually attracted to children but do not sexually abuse them. A school of thought believes that a portion of child sexual abusers, are attracted to adult females as well. However, from research and knowledge, this attraction is part of the mask to disguise who they really are. When scientists have tested this, they use pictures of adult women's naked bodies, adult male naked bodies, and children's naked bodies, the findings are always the same. The preference is for the child's naked body. The same thing occurs with homosexuals that are married to women, who do not want to admit they are, or found out. Bisexual men tested in the same way, also show a preference for males. Before we begin, you must know there are different types of pedophiles. Despite what is believed pedophiles are homosexual, by orientation that are sexually attracted to prepubescent children., They may be married, but this is a cover up, for what they truly are. There is no difference between somebody that sexually abuses children and still has sex with women; this is just part of their mask. Pedophiles have an age preference for their victims, Nepiophilia, or Infantophilia, refers to the type of pedophile that prefers toddlers and infants (0-3), all pedophiles have child ages that they prefer, it usually is an age that they themselves had a significant event happen. Although they are homosexual in orientation, they do not prefer children of either sex. Children have hairless, non-sexual bodies, are tiny in stature. It is the child's unquestioning innocence that the pedophile is wanting. Chronophilia refers to prepubescent children. The next, types of Pedophiles refers to post pubescent teenagers, and is being revised, to NOT be included as being Pedophilia, (it is not the attraction to children). Ephebophilia also known as Hebephilia refers to post pubescent adolescents. Pederasty refers to the attraction of male adolescents The Lolita syndrome, refers to post female adolescents.*

*1. A pedophile wears a mask, and looks like everybody else. All pedophiles are the same underneath the mask, just some have a better mask than others do. An educated professional's mask is more deceiving than an uneducated person's mask. Pedophiles will often even choose a career that means they are in direct contact with children and this is difficult for society to accept. We trust our children are being looked after when in the care*

*of teachers, priests and the medical profession. Caring professions are the best masks for pedophiles, as these professions are the most respected. How could a person who is so well respected, promotes and prolongs life, be capable of sexually abusing children? Remember they are wearing a MASK, and then you will know the answer*

*2. Narcissistic Personality. Everything is about them. They are very insecure by nature, and surround themselves with what makes them feel good, unfortunately this results in them being isolated, as no one can live up to their expectations, except children who are coached and learn to please the pedophile abuser. Look at the people a person does or does not surround themselves with and you will know more about them. Those who are surrounded by arrogant people are arrogant; drug addicts surround themselves with drug addict people. Pedophiles are surrounded by children, or put themselves in situations where children will be. Theme parks, parks children play in, activity places like rug rats. Public pools and beaches were children frequent e.g. .small beaches. When you know their motivation, you will then start to detect the pedophile.*

*3. Pedophiles hate the police, and will go to extraordinary lengths to avoid them. However, there is a saying keeps your friends close and your enemies closer, and pedophiles will coerce police if needed, to deflect attention away from them. You are dealing with the best manipulator that exists.*

*4. Pedophiles are liars, the objective is always self-serving. They will say whatever it takes to keep their secret. You will be convinced of what they tell you, but they will convince somebody else of the opposite if it works to create conflict and keep their secret. They are sociopaths as well, and this is not known by many people. They orchestrate events, by setting people up with information and lies. Then they sit back and watch their own play, knowing how it ends. But the actors have no idea, that they are even in the play, but they all have important roles. Few people will know they have been used by a sociopath this way. But a person who knows the pedophile, and is trying to expose them, finds out. THE PEDOPHILE IS A SOCIOPATH.*

*5. over involvement in children's activities. The pedophile has the mentality of a child, and relates well with children because of this. He does not relate well with his own peers*

*6. Pedophiles are misogynists, who become this way because of the own relationship that they have with their own mothers, who they come to despise eventually. Most pedophiles have not been sexually abused, although the ones that do more often come from an incestuous family and it passes on from generation to generation. Pedophiles are all age specific about their victims, and this is because the age choice of the victim is the same age they themselves were when a significant event occurred in the relationship they had with their own mother.*

*7. Pedophiles, become pedophiles in their late teenage years. At first, they will believe that they are impotent, they will not be aroused by female or male adult bodies. They discover however that they are not impotent, and are easily aroused by children, who do*

*not have to be naked. It is what a child represents, that the pedophile is sexually aroused by, their innocence. male adult bodies. They discover however that they are not impotent, and are easily aroused by children, who do not have to be naked. Pedophiles, become pedophiles in their late teenage years. At first, they will believe that they are impotent, they will not be aroused by an adult female, or male. Rather a child and they do not have to be naked. It is what a child represents, that the pedophile is sexually aroused by, their innocence.*

## **METHOD- Part Two**

## **Application of knowledge**

### **ACTIONS TO BE TAKEN BY NEIGHBOURS**

*Secretive behavior is employed by the pedophile, remember they are leading a double life Wives of pedophiles do not even know they are pedophiles, but a common thread is not only a relationship filled with conflict and deceit. Often the pedophile is likened to Oedipus, in that Oedipus was in love with his own mother. The Oedipus complex developed by Freud, is based on this however the son of the Mother is controlled by this woman, he seeks her approval, but engages in activities he knows she disapproves of. His existence revolves around his dependence on her, but he actually despises, if not hates his own mother. This does make a lot of sense, as it is her control of him in childhood that was the catalyst for him becoming a pedophile, this is discussed later on. Upon reflection, pedophile husbands spend many hours in activities away from their marriage that they account for being an activity that is work or for the benefit of the family. When in reality those long hours are self-serving pedophile activities. Hours on a computer, hours on photography and video skills, Internet usage, that is supposedly for something else, other than pedophile activity. Bursts of anger if questioned about their activities, and the time they have spent engaged in this. Children of the pedophile are objects to amuse the pedophile, who engages himself in their child activities as if he himself were a child playing with them. He will want children to sleep in the marital bed, he is sexually not interested in his wife. He uses a child's body to comfort himself; over stroking of a small child is a form of sexual abuse. He will often expose his genitals to his own children, but choose appropriate times to do this, so as not to draw attention to his deviate intentions. Children will be observed by him when bathing and it will become an embarrassment to them, as they get older. Children will be continuously photographed in the bath, when naked; this could almost be seen as normal, if it were not for the quantity of photos. Any activities where children are sometimes naked, these children will always be naked, and there will be copious photos of these activities. Presents bought for his children, will really be for himself, or for him to carry out his activity. Pedophile fathers have been known to purchase cubby houses for their children, with the intention of using them to sexually abuse children. If a cubby house is custom made to fit the children's father, and away from the main house, with custom made bed and mattresses that fit the man, this is more than sinister. Watch for the children's reactions about the cubby house, especially when the father is not at home. All ex-wives of pedophiles agree, that the mentality of the husband was the same as the children, but more demanding than all the children put together. It is as if the pedophile thinks he is actually small as well, when playing with his children. He does not obey rules, about his size, and will be seen to be playing on children's equipment in parks, it is not funny, and he endangers small children's lives and breaks the equipment.*

*Children are known to be narcissistic by their very own nature and this is unique to children, but pedophiles remain this way. The pedophile will ruin the lives of all his family members without caring. Unlike a child, he is incapable of loving anybody but himself. Every child is unique and special, but all children are a gift, given to parents to be loved and cherished, with this responsibility comes the greatest love of all. Nothing else compares to the love a child brings into the life of a parent, there is no greater love. No normal human being can understand how a father can take away the innocence of his own child, and feel nothing. Then do absolutely everything to protect himself. When the wife and mother of his children have discovered his secret, 75% of the time, she is removed from the lives of her children. With the elimination of the mother, he is now sexually abusing his own children even more. No one is watching him,. This man is now out of control, capable of anything. The children are in urgent need of protection, but nobody knows. You live in the street where this is happening, only you, the neighbors can save these children now. OBSERVE, notice behaviors, notice the house, look TAKE NOTICE of anyone coming and going, get there license plate numbers .LISTEN , write down what you hear, this is extremely important Get PHYSICAL EVIDENCE, take out your CAMERA and take pictures of anything SUSPICIOUS. TALK to the CHILDREN, and RECORD your conversation. He is out of control; you will see this, INFORM THE POLICE! INFORM DOCKS! KEEP INFORMING THEM UNTIL THE CHILDREN ARE TAKEN INTO PROTECTIVE CUSTODY .You never got this information, loose the paper there is to be no evidence.*

*Always remember that pedophiles are connected with other pedophiles, they are members of a ring. They use alias names, as members in a pedophile ring. But they do like to share there activity with other pedophiles. It does not have to be done over the internet that would mean getting caught. Although with wireless technology , any mobile devices that can transmit data are utilized .Mobile internet data, uses radio waves, and goes unnoticed.*

*Because pedophiles, are so used to using the internet, they are finding better methods not to get caught. Over 80% of pedophiles, have been involved in other criminal activity, and with there computer knowledge, when they live in the street you live in, make sure your internet is well protected pedophile can easily use your information and proxy address, to view child pornography, and they will not be detected by authorities who look at all this information, you will be, as your information was stolen and used.*

*It is not restricted to crime relating to child pornography either. Your bank accounts can be hacked, as passwords, can easily be extracted, when you have the knowledge that computer experts obtain. A pedophile certainly has become an expert at using computers, and all new technology. THIS IS A FURTHER WARNING.*

*You definitely do not want this MAN to live in the street that you live in!*

## **CHILDRENS IMAGINATIONS**

*The truth is a secret*

All children from a very early age, even before they can talk need to be taught what constitutes a secret. Even the toddler who cannot speak, can be made to understand the concept, the important thing is that the information is understood as best can be expected for a child this young. Children really do have incredible imaginations, they can create a fantasy world, and they are so innocent and trusting and let adults into this world. A Child's world is magical, and if you as an adult involve yourself in their playful imaginative world, you will become part of the magic that creates this world and make not just a child's life but your own life more meaningful and special.

Pedophiles use the imaginations of innocent children, not to create a beautiful magical and safe world for children. Children's imaginations are one of the reasons, a pedophile gains control of a child. Fear is used, with the use of the deviate mind of the pedophile, on the innate trusting nature of children, a young child believes what they are told, they have no reason not to. The child who is told to keep a secret, and if they don't something tragic will happen., like your mother will die, your sister will die, your brother will die, daddy will go to jail, mummy will go to jail, your pet will die, What is understood by the child is they are responsible for the consequence of telling the secret. The child, who is protected by a mother, when the pedophile is the father, will not tell, and why experts find this hard to believe is astounding. It has to be because adults judge children's behavior by their own adult perspectives, what they imagine a child should behave like. More interesting still, they themselves with all their education, do not comprehend the mask . These experts, are not experts in the psychology of sexually abused children's behavior portrayed by a pedophile, they are dealing with a sociopath, and one who is using them to his advantage. The Family Court is about child custody, it is expected that both parties will throw dirt at one another. But the Pedophile is doing more than that, He cannot fool the mother of the children, so he will be trying to eliminate her, she is dangerous for him. She will be painted black, and the lawyers are the ones to do it. This is never about the safety of these children. The pedophile is using his own children to protect himself, he does not want to get caught. When it is realized that in the circumstances the mother 75% OF THE TIME WILL LOOSE CUSTODY , of all the children .But not only will she lose custody, when the husband is guilty, she will never see her children again. This is because she is too dangerous a threat. Worse the child/children victim, with the mother eliminated, has absolutely no escape from the sexual abuse that will become ritual, and more perverted in the absence of a child's mother. This will not, stop at the end of childhood. INCEST, with the absent mother will continue into adolescence, and this is a fact. NO ONE IS WATCHING, the pedophile is out of control. He will not stop sexually abusing his own children, unless he is caught.

### **GOOD AND BAD SECRETS**

The secret is how to get the sexually abused child to tell the pedophiles putrid secret. First children need to have it explained in ways that they totally understand, all children are different, so many techniques need to be tried until one is found for that certain child. There are TWO types of SECRETS and secrets do NOT have to be KEPT SECRETS The FIRST secret, is the one that if you tell, it ruins a surprise that was something good, but no punishment will be given for this, we are all allowed to make mistakes.. The SECOND type of secret is the secret that if you tell, something really BAD will happen. THE CHILD MUST COMPLETELY UNDERSTAND THIS.

The SECRET, that if told something bad will happen, is THE SECRET THE CHILD MUST TELL, the child must know that they will not get into trouble, and even if they have been told they will. Or something devastating will happen, it will not. (Remember children

believe what they are told, if they believe that they will be protected by a higher power and that the PEDOPHILE SECRET will not be revealed to the pedophile, which they are petrified of the consequences the pedophile has promised will happen if the SECRET is ever told by the child to anybody. BUT, THE CHILD WILL TELL, they really want to anyway, if professionals in the area of child sex abuse, and all women, most importantly MOTHERS, but school teachers, and any women in regular contact with children know that FEAR NEEDS TO BE TAKEN AWAY. This is obvious, but to achieve this starts at home, with imaginative play, and belief in God. Take the fear away, and the pedophile loses his power. He no longer will be capable of control. Like the child victim, he is now scared lonely and frightened, his cover up has been uncovered, ,(THE PEDOPHILE SECRET) The child must tell to a trusted Women, often a school teacher, whoever she is it will be representative of the own Childs mother. Obviously the own child's Mother is the best choice, but sometimes ,this is not possible ,because of fear ,unavailability, or they have already tried and not been believed.

The child understandably may be too scared to tell their own MOTHER, when the CHILDS own DADDY is the PEDOPHILE . 99% of sex abuse is by a male, and 65% is INCEST, or done by a relative or close family friend, but it is a MALE. Always tell your Mummy!

Pedophiles use the INNATE natures of children to premeditatedly sexually abuse them. They choose the child victim and groom them for their own sadistic pleasure. The take home lesson, use their technique, against them, so that they will not be able to inflict there putrid selves on an innocent child. Enter the world of the imaginations of small and school aged children, and let your imagination be the tool that protects the child from the deception of a pedophile. Something to remember is, a pedophile is narcissistic, he is incapable of not only remorse or empathy, but also LOVE, except for himself.(Narcissus died whilst looking at his own reflection in the water, because he could not bear to look away, he thought he was that beautiful). A child feels love, and knows when they are not.. LOVE is not only real, but the most powerful tool used to teach. FEAR is also felt by children but it is proven to not work well when teaching.

Now the fun begins, start getting very creative, it is essential and it has to be a lot of fun. Children learn better and remember better, when they learn with fun, and they will want to do it over and over again, A Childs world is the world created by their parents, circumstances and environment, Mum and Dad make the rules, but who makes the rules for Mum and Dad? A CHILD MUST BE MADE TO BELIEVE IN A HIGHER POWER and this is God. Create magic, for your children and make them believe it is real. The magic is for the Childs protection, and rewarding good behavior. This magic created by parents, must not be known to the children, BUT,BE WARNED,ADULTS WHO INGAGE IN THIS CREATIVE PROJECT,HAVE TOO MUCH FUN, it gets results so quickly, that its addictive for both child and adult.

Because sexually abused children do come from a home were domestic violence exist, and 65% OF SEX ABUSE IS INCEST. Single mothers, are targeted by pedophiles, the new boyfriend may be a pedophile. The home lives of sexually abused children is out of control, routines are nonexistent, and there is lack of child focus. The focus is on the pedophile, and how everybody must please him. He is a child mentally, and has no boundaries. The dad, who will want to play with the children at any hour of the night, has to be accepted by the mother, she has to make sure he is happy too. The children will sleep in the parents bed as well, or the pedophile will join the children in their beds, whatever works, so that a child can be easily accessed, The child is the object, what they represent, innocence, the pedophile wants to almost be like that child, a little child sleeping next to a pedophile is comforting and reminds them of their own innocence as a child. What most people would not know is that when a child is overly stroked, it is a form of sexual abuse.

Many sexually abused children are so used to this stroking that they find it hard to go to sleep without it. Don't believe the pedophile's explanation for the over stroking, CHILDREN NEED IT OR THEY WON'T GROW. The pedophile is sexually being turned on by this stroking the child mentally masturbating doing it, while his wife is in the bed. He is Oedipus, this must be a weapon you use. Children need routines or they are not happy children, and you have to insist on it. When he challenges you about the routine, always, remind him that his mother would approve, remember when you were a child and disciplined you (THIS IS WHEN THE PEDOPHILE WAS IN LOVE WITH HIS OWN MOTHER), even say you are going to ask for her help. He will not want his mother involved in his personal life, so do not worry, he hates her now. Wives of pedophiles do not have a good relationship with his mother. The pedophile without the wife or mother's knowledge has created so much conflict between the two, so that they do not like one another and both will become critical of the other one especially about raising children.

We know, Children who have been used for the enjoyment of a pedophile father, are very hard to get into a routine, not just, because they have not really had one, but there is opposition from the pedophile, and many children will be scared. But love will overcome the fear, especially when Angels are there to protect them, fairies are there to bring rewards and magic is real, a routine that is consistent brings comfort, the child knows what to expect, children are not happy unless they are disciplined and know the rules. BE CONSISTENT, always do what you promise, this creates TRUST. The Mother does this, the pedophile is mentally a child and incapable of parenting. The result will be that the child will trust the Mother. Every day in your own way, make a child believe that they are unique special gifted good and loved, even when they have been naughty MAKE THIS MESSAGE CLEAR, (unconditional love) They must understand that their mother is not alone in believing this about her children, of course other relatives and friends do as well. But sexually abused children come from an isolated environment, and when they are abused it is done in secret SILENCED BEHIND CLOSED DOORS, nobody else except the pedophile of course. , Angels are not seen and this is a benefit for a very important reason. Angels know better than mothers about children, but when children do not have their mothers with them, they must believe their own Angel is with them, and many other Angels as well, A child being sexually abused, is scared alone and frightened, and at the mercy of the pedophile, the belief in angels will help this child cope with the abuse. Also, Angels report how the child feels straight to heaven, and then miracles happen. "Suffer the little children who come unto me, for there's is the kingdom of heaven". It is documented that many sexually abused children that have disassociated and are on the spiritual level see Jesus come to them to love and comfort them after the sexual abuse has finished. When children go to bed at night, always read to them, and choose stories that have moral meanings that a child understands, There are books and card packs, on Angels, Fairies, Mermaids & Dolphins as well, by Doreen Virtue Ph.D. The card packs children absolutely enjoy. When your children are in bed at night, bring out a pack of these cards shuffle them, and let the child choose a card. The card will have either a picture of an Angel, Fairy or Mermaid Dolphin on it, as well as the character's name. There is a message written on the card, and they are powerful, wise, meaningful and loving messages. Your children will believe the message is just for them and from the character on the card. Children will really believe in what Doreen Virtue promises. She did not intend for these cards to be used in the way just described. Every child at some stage thinks that they have seen a Fairy, play on this, getting children that have been sexually abused to sleep at night is extremely hard, but if fairies visit when they are asleep and leave fairy dust and little gifts, it is easy. This is for all children boys and girls, sexually abused and not sexually abused. The goal is to get children to trust, this means routine, consistent discipline and making sure that children use their imaginations play, and have fun. A Child's job is to learn to play, and this must be learned, by the age of 9, if a child does not learn how to play and be happy by this age, as adults they will not be happy be-

cause they have not learned how to be as a child. Happiness is only learned in childhood, and it is learned with the use of a Childs imagination and creative play. A child must believe that they are loved and protected by a higher power. This is paramount for their own psychology, and healing, which is so damaged from child sexual abuse, especially incest, These adults that survive the abuse need the tools to do so, and they are learned when they are children. These tools will help, the scars heal better, they will never completely go away, but they can be made smaller, and there relationships with other adults will be enriched. Because they have always known, that only one thing in life is real, and it is not a secret, it is the truth, it is LOVE.

## THE SECRET BOX

The child that has been the inspiration of this strategy, also insightfully gave a method of how the pedophile secret can be told ,with words. To enable a sexually abused child to give a disclosure, there has to be no guilt or fear felt when they disclose the SECRET. You must know how difficult this would be for a small child, who probably has been told that something catastrophic will happen if they reveal the SECRET, mummy will die, your sister will die your brother will die etc. This method works because it uses what the pedophile is attracted to in the first place. A Childs innate nature, trusting innocence and creative imagination. Just as children are a gift from God, so too is this information. Method of getting the sexually abused child to disclose.( given by a sexually abused child who never told ,but once had the opportunity, and wished that she had told

**I WISH I WERE A BRAVEHEART LIKE MY SISTER, I WAS MUMMIES CRYSTAL CHILD AND ,HERE IS THE WISH, I WISH I HAD.**

**I was too scared that Daddy would find out ,and I only got one chance at it, and now my mummy is not here anymore. I miss my mummy.**

All Mothers possess a secret box, given to them by GOD, this box is used for only one thing. That being a secret, that a child does not want to be responsible for telling ,and being found out for telling At the same time this small child does not like the experience of what happens to them ,that then becomes the most powerful secret, they are responsible for keeping.. If a child is made believe this box only appears when the secret is to be put into the box by the mother, who then sends it straight to heaven, where GOD fixes it. Mummy forgets the secret herself, when she puts it in the secret box, which is then sent directly to heaven.. It relieves the child of guilt and fear about revealing the secret, and relief felt in telling what was never meant to be told. Because the child does have affection for the pedophile as well, who will, often be their own father. If GOD can fix the Childs concern "keeping the secret", without the pedophile finding out, **IMAGINE THE RELIEF.** God can do anything, much more powerful than a Narcissistic Pedophile..Mothers forget the information, as soon as the box is filled with the secret, and sends it to heaven. This is a win win situation, as many pedophiles are religious, and will preach about how great God is. (Mothers need to get creative with what they want to use with a secret box, but make sure the box is beautiful, and once used, hide it very well. The child has to believe it has gone to heaven .The Box returns, when a child has another secret that they want to put into the Secret Box.

## RITUAL SATANIC ABUSE

*Ritual Satanic Abuse sounds like something from a science fiction novel or movie, however this is the reality of many sexually abused children's lives and for this reason needs to be exposed so that it can be identified and eliminated. Ritual Satanic Abuse involves organized sexual abuse of children which is the most severe form of child sexual abuse and more than difficult for most of the population to comprehend how a parent could allow this to happen to their own child. It would be easier to believe that these parents were born into some kind of a cult and allowed this to happen to their children out of some kind of fear. However this accounts for only a small minority of cult members who carry out repeated ritualistic abuse on their own and other children.*

*The main motivation behind Ritual Satanic Abuse is not sexual but about power and control which almost fifty percent of the time is carried out by women. This statistic is more than disturbing knowing that women make up only one percent of pedophiles, but it does explain that their motivation is anything but sexual and makes what they are doing seem even more unforgivable than what many pedophiles are doing to children because they are sick and have lost control. The repeated physical, emotional and spiritual assaults on innocent children combined with the systematic use of symbols and secret ceremonies is developed to turn a child against itself, family, society and God.*

*This is the worst crime that exists against children and it is also the only crime against children that the abusers are well protected by other people who know exactly how these children are being abused, who are also aiding the abusers in carrying out the abuse of children. This most sadistic and cruel form of sexual abuse goes mostly undetected, and is carried out for many victims entire childhood. There are many reasons why this abuse is not detected that are for the same reasons that non a cult sexual abuse is not discovered. However for RSA of children members of these organizations use mind control techniques to make sure that the abuse is never discovered and if a child or adult in later life ever discloses the abuse the disclosure is so bizarre that it is unbelievable and will be thought of as part of an existing mental health problem.*

*The objective of the mind control of these defenseless innocent children is to cause multiple personality disorders. When a child has developed multiple personalities as a consequence of what can only be describes as sadistic torture which is inflicted usually by the child's own parents, the horrific abuse will go undetected because the personality that exists along with other personalities a child has now developed, is the personality that is sexually abused. This personality a child will not recognize as being part of themselves, it is a personality outside of themselves which may be some TV character or a character evoked by their imagination but the character has a name. This also explains what happens when children have imaginary friends some are good and some are bad. When these children are away from the abuse and in the company of other children and adults they are in no need of the personality that is abused they don't like and see as a separate entity form themselves anyway and it is never shown to the outside world. This explains why when these abused children are at school there are absolutely no signs of abuse, these children are often very successful children from what is thought to be a good background coming from well educated parents who have very important jobs. This happens because the personality that attends school is the good personality the one that a child victim most wants to be like, one that is good and because it is good will not be abused. A child is said to have SPLIT once they have developed multiple personalities.*

*There are no accurate statistics available to know what the percentage of children is that are sexually abused because not only do children not disclose sexual abuse out of fear but when the abusers are so well protected as members of a secret society and the children have developed multiple personalities that enable the most severe sadistic sexual abuse to never be suspected and ultimately never detected. What is obvious once this knowledge is available is that the statistics available about pedophiles that are sexual abusers of children does not in anyway reflect the amount of children that are sexually abused when this sexual abuse is being carried out by non pedophile women as well as sexual abusing pedophiles in very well protected cult settings. This also means that it has to be realized that many innocent children have absolutely no way of ever escaping from this sadistic cruel existence when there is no protective parent or family member to disclose what is happening to them anyway. When both a child's parents are members of a cult a child has absolutely no hope of escape and it is very easy to understand that a child's mind for its own survival has to disassociate and SPLIT. This reality is very hard to accept and is being ignored by our society which leaves little hope for these innocent child victims and many of these children will not live. There deaths are very cleverly covered up by other cult members and assisted with the use of doctors , lawyers, judges, police and other professionals but also priests and other religious orders who are cult members existing in a secret society. This also explains why when a few of the minority of children and adult survivors of Ritual Satanic Abuse disclose this abuse and the activity of members in cult ceremonies not only is what they allege bizarre and unbelievable what they allege there is no evidence to prove anyway.*

*There is hope for the young child victims of Ritual Satanic Abuse that have developed multiple personalities with the use of this strategy that involves observation and knowledge to detect sexual abuse. This is because many of the behaviors of these small children are not carried out in the conscious mind where the front personality is on display. The behaviors that are a result of Ritual Satanic Abuse are stored in the subconscious mind and are on display without the knowledge of different multiple personalities and these are the signs of sexual abuse. The characteristics of small children that are Ritually Satanically abused will be the same as for all sexual abuse with the added fear of symbols imagery and codes used as part of secret ceremonies. Children that are victims of RSA when more than one person carries out the sexual abuse there is physical evidence of this that upon examination by a doctor which is concrete evidence that cannot be ignored.*

*Satanic organizations as well as the CIA, FBI and other secret criminal agencies, use not only severe sadistic sexual abuse to create disassociation and multiple personalities in child victims. What has been termed the Monarch Mind Control Program is used to create Multiple Personalities referred to as ALTERS which are used for different tasks. ALTERS can be accessed by anybody who uses the "Codes" and "Triggers". Which could be telephone tones, nursery rhymes or dialect form movies usually Disney movies. The different tasks usually involve criminal activity ,drug smugglers( mules) couriers and assassins. The majority of child victims come from generational satanic families (bloodlines ) Then there are the child victims that are expendable (non bloodlines) that come from orphanages, foster care homes and from incestuous families with a long history of pedophilia. The Monarch Mind Control Program is designed to cause intense trauma through use of electroshock, torture , sexual abuse and mind games to make the victim dissociate from reality and cause multiple personalities. The following is a partial list of the forms of torturer. 1 Sexual abuse and torturer. 2 Confinement in boxes, coffins. Cages. 3 Restraints with ropes, chains, cuffs etc. 4. Extremes of cold and heat, e.g. ice baths and the use of burning chemicals. 5 Near drowning 6 Blinding light. 7. Electric shock. 8 Forced injection of offensive bodily fluids and matter e.g. blood, urine, flesh and feces. 8 hung in painful positions or upside down. 9 hunger and thirst. 10 Sleep deprivation. 11 Sensory*

deprivation 12 The use of drugs to create illusion, confusion or amnesia. 13Limbs pulled or dislocated. 14 Application of snakes, spiders, maggots and rats to induce fear. 15 Forced to perform or witness abuse, torturer and sacrifice of other people, children and animals usually with knives. 16 Forced to participate in child pornography and position. 17 Raped to become pregnant and then sacrifice the fetus. 18 Spiritual abuse so that the victim feels possessed or controlled internally by spirits or demons. 19 Abuse and illusion to convince victim that God is evil, God raped you. 20 Use of illusion and virtual reality to create confusion and non credible disclosure..

Satanic Pedophile Rings are not a figment of the imagination developed to create fear and terror in our society. This is reality and that is what our society does not want to accept and if our society would accept this then these cults and secret societies could begin to be exposed and eliminated. When knowledge is acquired about what constitutes the profile of a pedophile, it is plain to see that in order for pedophiles to continue to sexually abuse there preferred age victim without consequences this is easily achieved by being members of a cult, a satanic organization which ensures protection from being exposed. The use of the word ring to describe pedophile rings is satanic in origin and describes organized abuse as well as sharing between members evidence of this crime against innocent children. Satanic cults carry out there activity within a circle often described as a ring, this is the circle of protection by existing cult members. The image of a circle and what is contained within the circle depicts for knowing cult members what abuse is being carried out contained in the circle of protection that will never be found out by non cult members.

Satanic cults exists on being insular, isolating themselves and their activity. However satanic cults are networked in our society both in Australia as well as overseas and this is how members of one cult are protected by members of another cult. When a member of one of these organizations has become exposed members of not only there own organization but others as well assist in making sure that cult activity is not exposed. This is the circle of protection in operation, this is corruption and how child sexual abuse is being covered up. Members of satanic cults and organizations are not only protected by this circle of power they are also forced to live their lives within this circle they are not permitted to leave and know better than to try the consequences are as horrific for themselves as what they are for non cult victims. It will cost them not only their own life but could also be the life of the members of their own family. This circle of power that protects as well as provoking fear in members contained in the circle is referred to as THE NEW WORLD ORDER, The Illuminati.

Members of a satanic cult are referred to as Satanists. Satanists are not about going to tell anybody that they are Satanists, just like pedophiles are not about going to divulge they are pedophiles. There are many similarities between Satanists and non satanic pedophiles in that they are both wearing masks to hide what they really are, they appear to be everyday ordinary people from all walks of life. This includes people that appear to be religious, born again Christians is an example of this, many who claim to be born again are in fact Satanists. There is a ceremony in the satanic church which requires a person to lay in a coffin amongst other things, and when the ceremony is over this person is said to have been born again. Priest of the satanic church have to be priests of the catholic church first which is very disturbing to know, but this is what is really part of the catholic cover-up it is just that society is unaware of this but the catholic church certainly knows. The truth is that Satanic ceremonies originate from catholic ceremonies first, but satanic ceremonies are mocking all that constitutes being catholic. Everything about Satanism is about the reverse of what it means to be Christian, even writing in reverse as well as reversing the position of the cross, to make it upside down and make a mockery of Jesus. Satanism is a rejection of all Christian values and morals, Sex orgies are a main

*theme in satanic cults and ceremonies and for this reason they have attracted many members wanting to engage in perverted sex. Satanists that are pretending to be good church abiding citizens underneath are using this front to actually cause pain and suffering to unknown unsuspecting victims, that includes friends as well as family members who are not part of or have the knowledge that these people are members of a satanic organization.*

*The illuminati is a very secretive group of occult practitioners who have been around for thousands of years, who are using the Jewish Cabala as one of their guidelines to oppress the rest of the population. It is an extremely well structured organization consisting of people in very high places. These people are the super wealthy, who stand above the law. Most do not appear on the list of the wealthiest people in the world, they are that secret. Driving their power, money and control over life and death of others and themselves.*

*The Illuminati consist of the 13 wealthiest families in the world, top players of the international playground. Super rich powerful elite with an ambition to create a slave society. Nobody can join the illuminati you have to be born into the illuminati. However ordinary people can join into their choice of secret societies. Satanic organizations that make up the New World Order and are governed by the illuminati.*

*There is wide spread corruption in the Family Courts of Australia, and clear evidence of the New World Order, the Illuminati in operation. The Family Court is responsible for allowing sexually abused children to continue to be sexually abused and this system is being exposed for the evil it has been committing without any repercussions. The fact that seventy percent of mothers are losing custody of their children for alleging sexual abuse in the middle of family court proceedings with misogynist lawyers and barristers using Parental Alienation Syndrome as the evidence that permits this to happen. The family Court is set up to fail in the protection of innocent children and protective mothers there is no hope of any justice in this existing system. There is no fairness or justice to be served in the Family Court only corruption, pain and suffering is seen here. The Family Court is in no position to make any rulings about child sexual abuse and this needs to be exposed and known to the general public. The only systems that can determine whether or not sexual abuse has occurred or whether a child is at risk of this occurring is the Police and Department of Child Safety. The Family Court cannot even make these departments carry out any investigations and yet the Family Court is being permitted to make rulings that a mother in the light that sexual abuse allegations cannot ever be substantiated, must be a coach and a liar who is not permitted to make any complaints in the future to either of these systems Police and Department of Child Safety when they suspect sexual abuse. This is corruption in operation it is as simple as that. This makes sure that a sexual abuser never gets found out. The Department of Child Safety and the Police are not educated about the psychology of sexually abused children and the Family Court and if they were they would not leave a system that cannot carry out any form of investigation into alleged sexual abuse of children to make a determination of fact. The only thing that the Family Court can do when sexual abuse of children is alleged is to subpoena documents in relation to this from Police and Department of Child Safety, which is not going to achieve anything as these cases of alleged sexual abuse are always unsubstantiated when in the Family Court. The cases that are substantiated by Police and Department of Child Safety are prosecuted in a Criminal Court where the standard of proof is much less stringent than in a Family Court. In the Criminal Court the test of proof is BEYOND A REASONABLE DOUBT and yet in the Family Court proof is based on The TEST OF PROBABILITIES, that being Briginshaw and Briginshaw, which only can prove that sexual abuse has not occurred. The only departments able to investigate sexual abuse of children will not get involved in any Family Court proceedings and yet their opinion that is unsubstantiated is*

*the expert opinion used by the Family Court who will make the same finding but does not have any power to investigate the allegation of sexual abuse.*

*For the Family Court to be permitted to make a ruling that sexual abuse has not occurred when this system has no investigative ability to make such a ruling is criminal. However to also be permitted when a ruling that sexual abuse has not occurred to make a ruling that a Mother has coached the child and is therefore emotionally abusive a liar trying to destroy the relationship between a father and his children is defamation of character and should be accountable for with criminal charges. Yet the Judges in the Family Court are protected from any litigation based on the outcome of family court proceedings. When our children are the most precious of all that there is and need protecting how can such an inadequate legal system be permitted to have the power that destroys children and protective mothers lives when all the statics and facts are readily available to these very well educated professional of the Family Court System. This is corruption in operation and a coronial inquiry into this is needed urgently.*

*I know without a doubt that a secret society is in operation and goes undetected within our society this is a satanic organization which is definitely networked. I have first hand personal experience of the existence of this society, not the secret ceremonies , the networking of members of different satanic organizations. The use of secret police that are not even real police and the infiltration of Satanists in the public mental health hospitals who are terrorizing many defenseless patients as well as psychiatric patients who along with staff at certain mental institutions carry out harassment and intimidation of other target patients getting personal gratification out of another persons upset suffering and fears. Organized crime, drug smuggling which is mainly cocaine, prostitution, murder, child kidnappings assassinations , Satanism and Mafia tactics are all in operation alongside of organized pedophilia. Money power and corruption are at the front of all this criminal activity, people in high positions in society, the catholic church which involves priests and brothers and finally family members. *The only way to put an end to corruption in the Family Court is with a crimmlinal inquiry to expose and punish this system for the evil it is creating and the innocent children's and protective mothers lives it is single handily destroying. This is the only way to expose the real horror of child sexual abuse to the general public with the use of the media. The very system put in place to protect children is the very system that is abusing our children. This system has not only failed this system is corrupt it needs replacing.*

*Satanic organizations use a lot of imagery to make there identity known. They use many different symbols that depict occult activity. Like pedophiles use code to communicate with other pedophiles so to do Satanists and satanic pedophiles to also communicate with one another. Society needs to learn and recognize imagery, symbols, and codes used by the occult. This is the only way that secret societies who are carrying out inhumane sadis-*

Every person in Australia is getting a pamphlet in their letter box, designed, to targeted the responsibility neighbors' have to open their eyes, and see what is in front of them, then take ACTIONS. The cover over this pamphlet is to have a picture of a **MASK**. Then the words, **HE LIVES IN THE STREET WHERE YOU LIVE**. Then after this at the bottom of the cover of the pamphlet. **YOU DON'T WANT HIM IN THE STREET WHERE YOU LIVE**.

This information is all in the pamphlet that Australian citizens receive, and it explains what they must do. It will work as it is so confronting, that it cannot be ignored, it is happening in the street they live in. It plays on the human emotion, concerns and natural instinct to protect the innocent, who cannot protect themselves. The phone calls can said to be anonymous, but the government can always trace the line. But the general public should not know this, as there is still an element of fear on the part of the informers

I will not give this to the Medical Board at the present moment it will not achieve anything and possibly harm me and my children. I have given my husband back the stolen hard drive after being stalked and living in fear with many attempts on my life being made. For me to tell the truth about what has been happening to me brings about the same fear I believe that my youngest daughter felt for telling me the secret. My youngest daughter after her first disclosure was promised that her Mummy would die and her daddy would keep doing what he was doing to her anyway. This is my babies reality now. To disclose is to hope for belief and change and that is what I an disclosing for. You need to know the whole Truth.*

*Because of the rules of the Family Court, children that are being sexually abused are 75% of the time not protected, they are abused even more, and this is not just disturbing. It is an Australian national tragedy. These innocent children have their mothers removed from their lives. It almost resembles what has happened with the stolen generation, and look at the devastating consequences of that. Our sexually abused children have to have*

hope... To have hope that there little lives will be saved from not just sexual abuse, and all the other forms of abuse that goes hand in hand with this. They must not be the living proof of what a pedophile promised would happen if they told the SECRET.

## TREATMENT OF A WHISTLE BLOWER

121 BOO

(Small girl virgin / Peek a boo paedophile orgy)

*This is something I have had more than a lot of difficulty writing about, not only is it very disturbing and unbelievable, it is hard to comprehend and has effected me psychologically, spiritually ,physically, emotionally and economically, simply every area of my life has been affected and damaged.*

*I am writing this so that it is known what has happened to me for exposing a paedophile in the Family Court of Australia, and is proof of the corruption in this legal system that is networked with other systems to support and protect paedophiles.*

*After I lost custody of my three daughters I ended up being thrown in a mental institution and given a false diagnosis of Paranoid Schizophrenia, being told that everything I thought was not real and that I was insane. My Nurses Registration was suspended for alleged drug abuse. My house was then given to my husband along with everything in my house which included all of my possessions as well as my clothes, spousal maintenance was ceased and any orders for supervised access with my children that were to be paid for ceased as well. This meant that after the ten weeks I was on an Involuntary Treatment Order in this mental institution when I was released I was not just without my children, I was homeless, possession less, without money, unable to work, and my identity as not only a mother but as a human being taken away from me with a false diagnosis of Paranoid Schizophrenia, I was totally destroyed and that was just the beginning of what was install for me.*

*Since I wrote the beginning of this strategy and after having my appeal accepted on the 27<sup>th</sup> of August 2010, I have almost been killed and had all my evidence for a new trial stolen as well the few possessions I had from my home, clothes and my Prado four wheel drive.*

*The people that I believed were helping me were actually not helping me at all. I had been set up and the lawyer that was so bad turns out was for a good reason, she was working for my husband and I had been played for a fool. This is not the worst of what I have learned and what I have discovered has taken several months to absorb and accept, its horrific and more than disturbing it involves members of my extended family that were involved in my custody trial, there is clear evidence of collusion to pervert the course of justice along with further attempts being made on my life whilst living under the same roof as my Aunty and Uncle. So much for don't let the opponent know your strategy, every single move that I have made has been known, and now it is the beginning of June 2011 and this has still not gone to trial. Cost certificates have been granted and the money received from mine have gone towards paying my first lawyer and corrupt second lawyer there is no money left for me for legal representation for a new trial and legal aid has been denied for the eight time. I have been struggling do all my own legal work and preparation for a new trial that is expected to run over three weeks. For a long time what was happening to me made no sense what so ever, but after living with my Aunt and Uncle everything became clear, its just more than horrific and so disturbing that its unbelievable especially when it is your own family the people that you*

have trusted for most of your life, that would see incredible harm come to your children and would see you dead. I have no parents since I was eighteen years of age and so my Aunt and Uncle are the closest relatives I have and there four children my cousins took on the role of Aunties and Uncles to my own children. I come from a very catholic background where three of my uncles have been priests and one De La Salle Brother who is very well known for all the work he has done for Boys Town and whose picture is on all the art union home pamphlets. For most of my life I have believed that my Aunt was a crazy charismatic catholic, whose stories I found very disturbing and unbelievable and I am not unique in my opinion it is shared by many others in our family. However this Aunt and Uncle along with there four children and more than likely my Uncle the De La Salle Brother have not only been living double lives and are protecting my husband assisting him in what is the most sadistic crime against our children. I do not claim to know everything but have been told many times by my Aunt that what I have discovered is much bigger than I realise, and that my children are the sacrifice so that other children will be saved. I would not listen to my Aunt saying that my children were the" sacrifice" and I told her many times to not say this about my children, however her words were chosen carefully for a reason and if I had not learned all that I have I hate to think of what the future may have been.

The reason I wrote this strategy in the beginning is because I was unable to sleep and I now know exactly why I was unable to sleep at that time, it was not just because of the hammering and drilling noises the minute I tried to go to sleep, I was under surveillance I was being stalked by members of a satanic cult and the two men helping me had only been pretending to be sincere. They were not business men as I had been told and believed, I had been set up with them when I was in hospital after loosing custody of my children. They are loan sharks, cocaine smugglers, criminals who use mafia tactics and also involved in this cult and when things were not going to plan the one I had been living in a unit with made plans to get rid of me permanently , I was told by him that nor only was I going to be murdered by somebody I knew but that it was also going to be absolutely horrific the way this was going to be carried out. The second last time I saw this man I was told that he had been" told there has been a change of plan and he had been tipped off by my husband to get rid of any paper work in relation to myself" and at that time this made no sense to me, but now it certainly does make sense as after that day the next time I saw this man he attempted to drag me away in his car for what must have been the end of there plan and as I was getting away from him he told me "You now have the Kiss of the Mafia".....he is Italian!

My Aunt and Uncle are Satanists and their children generational Satanists and that is what my husband is involved in and why he said that the only thing I had not accused him of is Ritual Satanic Abuse, and this is definitely what is happening to my children and there is clear evidence that this is happening and being allowed to happen. Within the family court exists a secret court where deals are being made with paedophile fathers that in exchange for them obtaining full custody, that their children are then also sexually abused by other paedophiles and even worse than this children are being used as some sort of experiment that purposefully causes trauma by methods of toucher to control the mind of a child and it involves RSA. The goal is to produce multiple personalities in children for many different reasons. What could be more traumatic for a child than having there mother who believed and protected them removed from their lives being told that their mummy would die because they told the secret. This is known as the Monarch mind control program, MKULTRA. A full investigation into The Family Court including all the professionals used that contribute to fathers of alleged sexually abused children gaining full custody needs to be carried out immediately. This legal system is set up to fail in the protection of innocent children and with 75% of Mothers who allege sexual

*abuse during Family Court proceedings losing custody of their children when only 2% is false, who never see their children again because of Family Court who will then make it an impossibility for mothers and their children to have a relationship. This legal system the Family Court is corrupt and needs exposing for the evil it is carrying out in the name of the best interests of the child that it is fully exploiting for the benefit of paedophiles, this is as simple as that.*

*When the Family Court has no investigative powers to substantiate an allegation of sexual abuse and will agree with what has already been unsubstantiated by police and DOCS, not only is this more than inadequate it is a system that can only fail in the protection of women and children. When sex abuse will not be proven in this court for the same court to then be able because it cannot prove this allegation make a ruling that the mother must therefore be a liar is criminal, and needs exposing. The only systems able to substantiate an allegation of sexual abuse are Police and DOCS, who are very uninformed about the capabilities of the Family Court and will not get involved with an allegation of sexual abuse that is already in the Family Court, which further fails the child victim as 98% of child sexual abuse in the case of INCEST is only discovered for the first time in the middle of Family Court custody proceedings which means that it will always be unsubstantiated. Finally to make sure that this system utterly fails innocent children of sexual abuse the Family Court in its utter corruption after awarding full custody to the father makes orders that the mother can never contact the only departments that can substantiate an allegation of sexual abuse as well as contacting these departments with the same order. How can The Family Court be seen as anything other than corrupt with its total lack of ability to investigate child sexual abuse but the total ability to remove a mother and make a finding that she is in fact a liar then make further orders that Police and DOCS never be contacted in relation to the sexual abuse of the children where there was a sexual abuse allegation that the Family Court would not investigate.*

*After I lost custody of my three daughters on the 19<sup>th</sup> of October 2009 many strange and bizarre things have happened to me, but also to a degree for the months leading up to losing custody when there was a DVO against my husband coming to my home. I was under surveillance before I lost custody I just did not know that I was, I had thought that my phone was tapped and it really was. Five weeks after I lost custody when my sister had just gone home and I was on my own, I found a piece of paper on the floor which had channel numbers that did not exist on it. I hardly ever watch TV so I went to find out what happened when I pressed the strange channel numbers, what I discovered was shocking the TV was being used as a monitor for covert surveillance usually done by Police where cables are attached to the TV that enable this to be achieved. I had no idea of how this worked or what it really was when I discovered it but I did pull out all the strange cables from the TV and wall and I also rang my husband and let him know that I had discovered what he had done to the TV, which he of course denied. I broke into my husband's town house and stole a hard drive for the computer, and it turned out that there was a lot of incriminating evidence on this hard drive. I lodged an appeal against the orders and made a formal complaint to the crimes and misconduct commission over Police corruption, naming all the police that were involved in my custody proceedings that did not do their jobs and failed in protecting my youngest daughter who made a disclosure of sexual abuse on a police video that was never investigated. I was making not only my husband furious with me, without knowing I had made many others angry with me as well and this is how I ended up being taken to the mental institution by the Police after discovering a man on the roof of my house at 1am in the morning camouflaged as a tree. The man on the roof of my house camouflaged as a tree has to be the most bizarre thing I have ever seen in my entire life, and I completely understand that this could easily have been explained as being delusional. However it is something that is possible as bizarre as it is and luckily was seen by two of my neighbours on the 5<sup>th</sup> of December 2009 in the*

early hours of the morning after I had honked my car horn in the street trying to get attention so that there would be witnesses to what I was witnessing and this is when the Police were called. The only reason that I saw this camouflaged man on the roof of my house was because that night I had been up late writing a music program to teach the piano that I had been doing with my two youngest children it was a music program that is very unique and very special to myself as it only developed with the involvement of my two youngest children and something that we all enjoyed very much and was exceptionally effective. This way of teaching the piano is by the use of colour numbers and names for the seven notes that make up one octave using creative imagination saw my two youngest children being able to make up their own musical compositions on the piano within a few weeks and I wanted to share and patent this and dedicate it to my children. Whilst I was writing I remembered how my youngest daughter had become upset in front of the TV that she could not explain why she was so upset. She had been watching a home movie with her father in it and at the time I thought that this is what made her upset and the court had accused me of making this child so scared of her own father that she could not even watch a home movie anymore. However she had been watching this movie for a while before becoming upset in August 2009, and I had begun to think that maybe something had actually happened to her in front of the TV and she could not explain this to me and that's what had upset her. Then I remembered the strange thick black cables that I had removed from the back of the TV when I discovered that it was some strange monitoring system. I decided to put them back into the TV and find out exactly what had been done to this TV. When I went to put them back in I discovered that they had been removed from where I had left them on the floor, someone had broken in whilst I was not there and removed them. I then went immediately into the attic of my house as there were also very strange cables in the roof of my house that were connected with twelve volt connectors that I had been disconnecting without anything obviously happening in the house, this was all very strange as well and I wanted to make sure that these had not been removed as well. Whilst I was in the roof I heard what sounded like somebody inside of the roof with me and I immediately got out of my house and drove away to get somebody to help me.

I was unable to get help it was 1am in the morning and the security man I knew who could help was not in the usual place, I know better than to contact the police. I drove back to my street and noticed that the main light was off when I thought that I had left this on, and that's when I noticed something strange on the roof of my house from the end of the street I immediately thought it was a person. In my car I have a pair of binoculars that I had been using to watch my children from across the lake where they were living in a town house with my husband. I looked through the binoculars and that is when I saw how bizarre and strange this person on my roof was camouflaged as a tree and I watched for well over an hour before alerting my neighbours. The man not only was camouflaged as a tree he was wearing strange red outlined spectacles which must have been night vision glasses and he would not move from the position he was in on the roof of my house. I also noticed the neighbours antenna on the roof of their back shed lighting up bright red which was also extremely bizarre but can be explained as they had been involved in helping my husband all year and this could have been a two way radio in use. I also noticed an old white Holden car out the front of my house that had the number plate 121 BOO as this was a very strange number plate and this car was never there before and I assumed that it belonged to the man on the roof of my house. Eventually this man moved and I then got out from my car and asked what he was doing on the roof of my house and that's when he spoke saying "Shut the f--- up" I was relieved he spoke as what I was seeing was so bizarre, I then honked my car horn with him protesting for my neighbours to witness what I was seeing.

*I ended up being taken to the mental institution by Police even though two neighbours made statements that they had seen what I had, the police were condescending and rude to me and I knew that this was because of the notification on there system. I tried to tell them this was not true about myself, and also asked them would they look in the roof of my house and they refused. I ended up telling them exactly what I thought of the police and that they had failed in protecting my children and this is the real reason I was taken to the mental institution. After I was released from hospital When I had driven past my house I noticed that the old white Holden car that turned up on the 5<sup>th</sup> of December 2009 was still sitting out the front of my house and believed at that stage it must have belonged to a neighbour however this is not the case and there is a very sinister explanation for this car that stayed parked out the from of my house up until the end of September 2010 out of registration since the 1/6/2009 which happens to be the same date that my husband got access to our children after the first custody hearing before sexual abuse allegations were ever made.*

*I knew that this old white Holden car had to be significant otherwise it would not have remained out the front of my house out of registration since the 1/6/2009 which meant it was already six months out of registration before it arrived on the 5<sup>th</sup> of December 2009. I thought it may have been used for surveillance equipment to be hidden, then I though maybe child pornography was hidden within this car and I even had someone break into this car and check that there was nothing inside of it. A car does not remain on anybodies property out of registration for coming up to eighteen months unless that person wants it there. When my husband said that the only thing I had not accused him of doing was ritual satanic abuse I had no idea of what he was talking about and did not think that this could even be real but I also know my husband and knew that I would have to find out what this actually was and that is how I found out what the car out the front of my house where my children are now living with my husband means. Paedophiles all use code to communicate with one another and members of a satanic paedophile ring have there own code that they use to communicate with and this is what the number plate 121 BOO was for, it was the code used to access my children by other paedophiles. 121 means small girl virgin and BOO means Peek a boo Paedophile Orgy. I have photos of this car that is no longer out the front of my house where my children are living and I doubt that the number plate was even real. I have no doubt that my husband learned that I knew what this meant. However the car was moved after I drove past the house at about 1030pm one night in a girlfriends four wheel drive. I pulled my car up out the front of the neighbours house number 13 , my house had every shutter open and every light turned on and as I was looking I saw a man trying to camouflage himself as a tree on the roof of my house over where my two youngest daughters room is. I had a camera that belonged to my girlfriend and was not sure how to use this, but I got out of the car and attempted to take a photo and as I did the man from number 13 along with another extremely muscled scary looking man came out yelling at me and I jumped straight into the car and drove away and as I did several cars came driving into the street very quickly. There has been an unusual sky window put over the part of my house where my two youngest children's bedroom is, so I guess if a paedophile was on the roof at the same time as a child was being sexually abused and looking through this unusual sky window and all the lights happen to also be on then they would be seeing what was happening PEEK A BOO PEDOPHILE ORGY.*

*I know the stalking that has been done to myself has to be people that are members of the same organisation, and I have also been flagged on government as well as non government systems as being a drug addict with mental health problems. In the beginning I thought that my husband must have been paying people to annoy and harass me, until this happened to me whilst living with my Aunt and discovering what she was involved with which is a satanic cult. I have been followed by working vans that are very large and always new either white or black, this happened after my Aunt gave my car away and I*

was living with her and walking on foot which was very frightening. Then there was a small new white car that every time I walked out the front of my Aunts house would immediately follow me which was any time of the day or night, somebody was always inside the car watching my Aunts house. Then there are the signals that I have seen whilst living in a unit before coming to my Aunts and the same night I saw a man camouflaged as a tree at my own house, where either torches are used or lights turned on and off in houses nearby that are signals to other stalkers to mean something about where I was at that particular time they signalled. I would come back to my unit having left the lights on only to discover they were all off and there would be somebody inside of the unit shinning a torch outside of the window, obviously that meant something. Then there is the whistling done usually at night that is used as a signal and has only happened to me a couple of times but I believe that it was when something very bad was going to happen. Then there is the coughing signal that is very scary and done usually by a male from inside where I was to signal to who ever is on the outside , the coughing is continuous and the male doing this will go over to the doors of the house so that the coughing can definitely be heard. I have also noticed this being done during court proceedings by my husband on the 27<sup>th</sup> of August 2010 which was the appeal, he was never asked to stop even though it was very irritating , annoying and obviously being done on purpose. I have heard this coughing signal done many times now and every time apart from when in court it was very frightening and resulted in me removing myself from what felt like imminent danger and I had thought that this signal was only done by men. However I have also heard when on the phone for my last court proceedings that was a directions hearing and meant for setting a date for the new trial which did not happen, the new female children's lawyer do the same continuous coughing that my husband did on the 27<sup>th</sup> of August 2010, there is no mistaking this as a signal and both my husband and myself were on phone lines not even present in the court room.

There are the usual white surveillance vans that are obvious but there are also other older white vans that are very disturbing and driven by Pakistan men. I have seen these only a couple of times once at my own house when I was alone with my two youngest children and one was parked out the front of my house that would not leave until I stood reading out what was written on the side of the van which was INTERNATIONAL MULTIMEDIA. The other was a night that I will never forget at my Aunts and the last night I ever stayed there was what sounded like a person climbing through the roof which was very loud and obvious. My Aunt could not hear this, however crime stoppers could whilst I was on the phone to them and I was urged to hang up immediately and ring the police as it was not the police as I thought it might be. I told my Aunt , knowing full well she could hear what was going on, and she became very angry then immediately got out of bed and went to the front of her property with me following her. Then out the front of her house was an older white van with three Pakistan men inside, she told them to "get out of here the Police are on there way", then went back inside with me following her very disturbed about what I had just witnessed. When back inside the house I could still hear who ever was in the roof over the part of the house where my Aunts bedroom is, and I rang for an ambulance and stayed on the line as I feared for my own life.

I have had to take desperate measures when my safety has depended on it because my Aunt gave my car away and ultimately my independence , the only thing that will frighten people who are tormenting you and when there is potential risk to your own safety if no action is taken, is to either ring the Police or an ambulance and pretend to be psychotic and if you say you have a weapon the faster they will come to where you are they have to. I am lucky to have the knowledge of how to get yourself put into a mental institution even though I swore that after I was really a patient in one that I would never allow that to happen to me again and it was the worst experience of my life. However faced with being a patient in a mental institution or being dead and never seeing my

children again, especially since my youngest daughter was told her mummy was going to die because she told the secret, I have taken the desperate measure of ringing either police or ambulance and being taken to the hospital. This has allowed me to see and experience for myself something I would never have believed possible especially since I am a registered nurse. This is the mental institutions involvement in stalking particular patients as well as giving false psychiatric diagnosis that are more than damaging and definitely silence a whistleblower permanently. The stalking and tormenting of targeted patients is done by both nursing staff and patients who have mostly been let into the institution for the purpose of tormenting and stalking. These patients carry out continuous hand signalling to one another when ever the target patient is in view and there is constant movement around the targeted patient that is obviously meant to frighten and intimidate. Then the psychiatrist who has knowledge of this stalking and tormenting will give a false diagnosis of Paranoid Schizophrenia that then gives everyone involved protection from any legal action being taken against them for what they have all done with full knowledge. I know for most this is unlikely to be believed as I would not have believed this myself unless I had experienced this for myself which I definitely have, and I must say that whilst working as a registered nurse I have only worked a few times on a psychiatric ward and that is because I found the staff more psychiatric than the actual patients. I have not seen this stalking done in every mental institution only one which was enough, but false diagnosis of Paranoid Schizophrenia was actually given to myself after I lost custody in the first mental hospital I was a patient in and I was also set up there as well. After having my home and possessions taken I met two older men one of whom was a patient, that wanted to help me with accommodation and getting custody of my children back and they had the means to achieve this. I have been in four different mental institutions since I lost custody in different locations three of these admissions were purposely done by myself for my own safety, and the mental institution where the stalking was carried out was in a small country town that happens to have the highest incidence of paedophiles in Australia, Lismore Richmond Clinic. I was stalked, tormented and intimidated in this town being followed and cornered by large working vans that disappeared as soon as Police arrived only to return once Police had left the area. This happened two days after the incident at my Aunt's house where the white van with three Pakistan men were asked to leave as the Police were coming, I ended up leaving that night and never returned. However my Aunt had a major involvement in all that happened to me in the country mental institution and I believe this is because as I was told by several patients that the hospital was a satanic hospital that Satanists bring children who have been sexually abused to be seen by their own satanic doctors so that the sexual abuse is never discovered. I have first hand knowledge that this is exactly what is happening in this country hospital.

I have first hand experience of being a patient in the public mental health system as well as a lot of medical knowledge about psychiatric diagnosis and over twenty years experience as a registered nurse which means I am more than qualified to give an opinion about the public mental health system which is, this system is corrupt and needs exposing. Because the general public does not have the knowledge about psychiatric disorders and this included the majority of lawyers, this system is being allowed to ruin many people's lives who are given an incorrect psychiatric diagnosis. It is almost impossible to find a lawyer who will assist any patient under an Involuntary Treatment Order, who will go against the mental health board. This is because of lack of knowledge not only about what constitutes a certain psychiatric diagnosis, but also no knowledge of the corruption that exists within the system that gives the psychiatric diagnosis. When anybody is told that a person has a psychiatric diagnosis such as Paranoid Schizophrenia this is believed and not even questioned, the psychiatrists are almost immune to having litigation taken against them for false and misleading diagnosis and once a label has already been given to a person what they have to say is not taken seriously anyway. This is really what hor-

ror movies are made of, there are perfectly sane people who live out their lives as patients in mental institutions throughout Australia. These mental institutions have the ability to totally destroy a person's life completely if a person leaves a mental institution whilst under an ITO the Police will be informed and a warrant for that person's arrest will be taken out with the Police believing that they are on the look out for some kind of psychopath. An ITO can go for as long as the treating psychiatrist chooses which could be years and even when the person is released from the hospital for the first six months the person can without warning be taken by Police back to the mental institution. However there are ways to also manipulate this system once you know how as I have done to remove myself from danger, but having to act psychotic to achieve this and not being able to tell the psychiatrist the truth does not give a person very much credibility when all these records are subpoenaed for court. This is when a very good lawyer is needed. There is a big difference between what a person should tell their psychiatrist and lawyer and this is all part of the game that I have been playing since my appeal was accepted on the 27<sup>th</sup> of August 2010 as my life has been in danger and if it were not for the Mental Institution there would be no new trial.

Stalking is real and it is networked as well. I no longer am being stalked as I have totally removed myself from the people involved in my custody battle, making sure that I told a psychiatrist my Aunt is a Satanist so that it is on public record even though it was said to look psychotic. I had no choice but to have this on my record because of the fear of what could happen to my children especially with a personal threat of harm to my children by my own Aunt.

Children that have been victims of Ritual Satanic Abuse are most likely not believed because the disclosures are very bizarre and unbelievable and they are told that nobody will believe them and that if they do tell it will result in what they fear most. I am aware that what I am also disclosing is bizarre and unbelievable and this is why it should be believed as anything to do with satanic cults is unbelievable and because of this members of these organisations feel protected and above the law. I believe that the truth will be revealed and that anybody involved in the sexual abuse of children especially when this is so sadistic and involves more than one paedophile abusing a child that this must be exposed and this is why I have told my whole story. My little four year old daughter trusted me and told me the truth and because I believed her she told the police as well and this is on video. I have to believe that somebody will also believe what I have had to disclose that has happened to me for exposing my daughter's truth that I will always have undoubting belief that it is the truth there is no other explanation for what has happened. *The Truth Teaches Everything!*

#### **HAND SIGNALS USED BY SNITCHES, FREEMASONS GANGSTALKERS**

This is a list of some of the hand signals that I have been subjected to and what I believe they mean after watching whilst I have been the targeted victim. Some people are expert at these hand signals while others are very bad, these are the ones you learn from'

There is a conductor who the snitches look to for instruction. They circle the target in a square they are on all four sides so as to feel like they are guarding the target.

**Squeezing the nose**      **Indicates I understand.**

1. **Open communication**

Pretending to yawn and placing a hand over mouth, or taking a drink to open communication. This is used to engage other informants.

Car patrols will flash lights to open communication with foot patrols.

2. *Coughing*

*Used to harass target, but a way to get other snitches attention, if an informant is not paying attention, cough or clear the throat. Then you will see open communication between informants being carried out.*

3. *On Watch*

*Rubbing the eye, putting glasses on, toughing the middle of the forehead (third eye)  
Placing headphones on*

4. *I Don't Understand*

*Pulling on one ear the receiver has not understood what the sender has said.*

5. *I Know*

*Briefly tapping or squeezing the nose indicates they understand. Double blink indicates they understand.*
